Engagement of retired Forest Officers as Instructors in Foresters Training School, G.Udayagiri and Nicholson Foresters Training School, Champua

Applications are invited from retired Forest Officers in the rank of ACF & Forest Ranger for engagement as Sr. Instructor / Instructor in FTS, G.Udayagir and NFTS, Champua for the existing vacancies i.e. ACF -03 (Three)nos. and Range Officer -02 (two) nos. at FTS. G. Udayagiri and ACF- 03 (Three)nos. and Range Officer -01 (one) nos. at NFTS. Champua. Retired persons who have worked in the respective rank can apply for re-engagement in the respective vacant post. The selected retired officers are to be engaged for a period of two year and likely to be extended subject to conditions. The details of Terms and conditions of engagement, remuneration, Application Format can be obtained from the Department website www.odishaforest.in .

Interested persons with requisite experience may apply in the prescribed format in a sealed cover addressed to the **Senior Administrative Officer, O/o the Principal Chief Conservator of Forests, Odisha, Aranya Bhawan, Chandrasekharpur, Bhubaneswar-23** so as to reach this office on or before 21.07.2018 by Speed Post / Registered Post only.

Terms and Conditions for Re-engagement of retired Forest Officers in the rank of Asst. Conservator of Forests and Forest Ranger as Sr. Instructor / Instructors in FTS G. Udayagiri and NFTS, Champua

Eligibility Conditions : As per Resolution dated 27.08.2014 of GA Department.

- i) Forest Officer who have retired from Government Service in the rank of ACF & Range Officer on attaining the age of superannuation and below the age of 65 (sixty five) years having good service records and physically fit shall be eligible to be considered for re-employment to the respective vacant post of ACF & Range Officer.
- ii) Officers against whom Departmental Proceedings or Criminal cases are contemplated / pending or who have been penalized for miss conduct during the period of preceding five years will not be eligible for consideration.
- iii) The person must have worked in the rank of Asst. Conservator of Forests or Forest Range Officer before retirement for which he has applied for.
- iv) The candidates having acumen for teaching would be preferred.

Selection Process :

- i) Selection of persons will be made through open advertisement.
- ii) There shall be a selection committee as may be decided by the competent authority for the post / posts required to be filled up by re-employment.

- iii) The applications received shall be scrutinized by the selection committee and only the shortlisted candidates shall be called for interview by the selection committee.

Tenure, Terms and Conditions:

- i) The selected candidates shall be engaged for a period of two years and can be extended for subsequent period for two years with spells of one year each subject to satisfactory performance up to a total period of four years **not beyond the age of 65 years of age** in any case or till the posts are filled up by regular process whichever is earlier.
- ii) Re-employed officer will be entitled for remuneration as determined by the Administrative Department / Appointing Authority with the concurrence of Finance Department.
- iii) Re-employed officers shall be governed by the provisions of Odisha Government Servant Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omission and commissions as per the provisions under the Odisha pension Rules, 1992.
- iv) The Re-employment can be terminated at any time by the respective Appointing authority due to unsatisfactory performance of any of the re-employed officer by giving one month notice. On the contrary if any re-employed officer desires to resign he shall do so by giving one month's written notice to the competent authority.

Job description :

- 1) The retired forest officers selected for re-engagement would work as "**Sr. Instructor / Instructor**" in Forester Training School, G. Udayagiri & Nicholson Forester Training School, Champua (as the case may be) for imparting desirable training to the Foresters & Forest Guards under training in the Forester Training School.
- 2) They would be assigned to teach different subjects in the Forester Training School under the direct supervision of the Dy. CF in charge of the Training School.
- 3) They are supposed to accompany the Trainees on tour to different part of the State as and when necessary under the course curriculum.

4) As the training is residential in nature, the faculties are required to maintain discipline of the trainees in the campus.

5) Any other works as assigned by the Dy. CF in-charge of the Forester Training School as and when required.

Accommodation: The re-employed officers would be provided with accommodation inside the FTS campus if available or House Rent as admissible as per the Finance department Memorandum no. 5554 / F dated 16.02.2012.

Remuneration: The selected Officers would be paid with the monthly remuneration as per the guidelines issued by the Finance department vide their Office Memorandum No. 7022 / F dated 17.03.2018 i.e. on re-engagement , the retired Government servant will avail remuneration only in consolidated manner as per prescribed remuneration structure attached to the level in the Pay Matrix under ORSP Rules, 2017.

Other Conditions:

1. The authority shall have the right to modify / relax any of the clause, not inconsistent with the provisions of the ToR, as he may consider necessary to regulate the matters not specifically covered by the provisions of this ToR.
2. The authority shall have the right to reject any or all the applications without assigning any reason thereof.
3. The authority shall have the right to modify the number of vacant posts to be filled up by way of re-engagement.

The interested candidates shall apply in prescribed format in a sealed cover addressed to the **Senior Administrative Officer, Office of the Principal Chief Conservator of Forests, Odisha, Aranya Bhawan, Chandrasekharapur, Bhubaneswar-23 on or before 21.07.2018 by speed / registered post only.** The name of Post applied for and Name of FTS should be clearly mentioned over the envelope and the application Form.
