**Engagement of retired Forest Officers as Instructors / Faculty
in Odisha Forest Rangers College, Angul.**

Applications are invited from retired Forest Officers in the rank of ACF & Forest Ranger for engagement as Instructors / Faculty in the Odisha Forest Rangers College, Angul for the existing vacancies i.e. ACFs – 4 (four) nos. and Range Officer – 2 (two) nos. Retired persons who have worked for a minimum period of five years in the respective rank can apply for re-engagement in the respective vacant post. The selected retired officers are to be engaged for a period of one year and likely to be extended for further six months subject to conditions. Interested persons with requisite experience and training acumen may apply in the prescribed format ^{in a sealed cover addressed} to the **Senior Administrative Officer, O/o the Principal Chief Conservator of Forests, Odisha, Aranya Bhawan, Chandrasekharpur, Bhubaneswar-23** enclosing the required documents by Registered Post/Speed Post only so as to reach this office on or before **20.02. 2018**.

**Terms and Conditions for Re-engagement of retired Forest Officers as
Instructors/Faculties in OFRC, Angul**

Vacancies to be filled : Assistant Conservator of Forests: 04
Forest Range Officers : 02

Eligibility Conditions : As per Resolution dated 27.08.2014 of GA Department.

- i) Forest Officer who have retired from Government Service in the rank of ACF & Range Officer on attaining the age of superannuation and below the age of 65 (sixty five) years having good service records and physically fit shall be eligible to be considered for re-employment to the respective vacant post of ACF & Range Officer.
- ii) Officers against whom Departmental Proceedings or Criminal cases are contemplated / pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.
- iii) The person must have worked for a period of minimum five (5) years in the rank of ACF or R.O before retirement for which he has applied for.
- iv) The candidates having acumen for teaching would be preferred.

Selection Process :

- i) Selection of persons will be made through open advertisement.
- ii) There shall be a selection committee as may be decided by the competent authority for the post / posts required to be filled up by re-employment.
- iii) The applications received shall be scrutinized by the selection committee and only the shortlisted candidates shall be called for interview before the selection committee.

Tenure, Terms and Conditions:

- i) The selected candidates shall be engaged for a period of one year and likely to be extended for further six months subject to satisfactory performance **not beyond the age of 65 years of age in any case** or till the posts are filled up by regular process whichever is earlier.
- ii) Re-employed officer will be entitled for remuneration as determined by the Administrative Department / Appointing Authority.
- iii) Re-employed officers shall be governed by the provisions of Odisha Government Servant Conduct Rules,
- iv) 1957 and shall be liable to be proceeded against for their misconduct, omission and commissions as per the provisions under the Odisha pension Rules, 1992.
- v) The Re-employment can be terminated at any time by the respective Appointing authority due to unsatisfactory performance of any of the re-employed officer by giving one month notice. On the contrary if any re-employed officer desires to resign he shall do so by giving one month's written notice to the competent authority.

Job description :

- 1) The retired forest officers selected for re-engagement would work as "Faculty / Instructor" in OFRC, Angul for imparting desirable training to the selected candidates for the post of Forest Rangers.
- 2) They would be assigned to teach different subjects in the Forest College under the direct supervision of Director Training, OFRC Angul.
- 3) They are supposed to accompany the Trainees on tour to different part of the State and Country as and when necessary under the course curriculum.
- 4) As the training of Range Officers is fully residential in nature, the faculties are required to maintain discipline of the trainees in the campus.
- 5) Any other works as assigned by the Director Training, OFRC Angul as and when required.

Accommodation: The re-employed officers would be provided with accommodation inside the OFRC campus if available or House Rent as admissible as per the Finance department Memorandum no. 5554 / F dated 16.02.2012.

Remuneration : The selected Officers would be paid with the monthly remuneration as per the guidelines issued by the Finance department vide their Office Memorandum no. 5554 / F dated 16.02.2012 in terms of category 1(a) i.e re-employment against sanctioned post having prescribed scale of pay under codal provision of O.C.S (Pension) Rules, 1992. The fixation of pay of pensioner re-employed will be fixed on the basis of the last pay drawn at the time of superannuation minus gross pension (non-ignorable part) drawn by the pensioner with suspension of T.I on pension as per F.D O.M No.38242/F dated 09.11.1994 shall be adopted subject to the fulfillment of the condition provided under sub-para (Vi) of para-3 of O.F.D.M No.50072/F dated 13.10.2009. Other allowances including D.A will be admissible on the initial re-employment pay i.e the last pay drawn on the date of retirement of superannuation.

Other Conditions:

1. The authority shall have the right to modify / relax any of the clause, not inconsistent with the provisions of the ToR, as he may consider necessary to regulate the matters not specifically covered by the provisions of this ToR.
2. The authority shall have the right to reject any or all the applications without assigning any reason thereof.
3. The authority shall have the right to modify the number of vacant posts to be filled up by way of re- engagement.
