
**NOTIFICATION**

No. FE-FE2-FE-0016-2023 4509 /FE&CC- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules to further amend the Odisha Forest Service, Group-A (Junior Branch) (Recruitment & Conditions of service) Rules, 2013, namely:-

1. **Short title and commencement:** (1) These rules may be called the Odisha Forest Service, Group-A (Junior Branch) (Recruitment & Conditions of service) (Amendment) Rules, 2024.  
(2) They shall come into force on the date of their publication in the *Odisha Gazette*.
2. In the Odisha Forest Service, Group-A (Junior Branch) (Recruitment & Conditions of service) Rules, (here-in-after referred to as the said rules), in rule 13.
  - (i) for sub-rule (2) , the following sub-rule shall be substituted, namely:-
    - (2) During the training, the trainees shall be paid each with salary and other allowances as admissible by the Government from time to time.
  - (ii) the sub-rule (3) (a), (b) & (c) shall be deleted.
  - (iii) the sub-rule (6) shall be deleted




