No. FE-FE2-FE-0016-2023 4514 /FE&CC- In exercise of the powers conferred by the provisio to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules to further amend the Odisha Forest Service, Group-B (Recruitment & Conditions of service) Rules, 2013, namely:-

1. Short title and commencement: (1) These rules may be called the Odisha Forest Service, Group-B (Recruitment & Conditions of service) (Amendment) Rules, 2024.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha Forest Service, Group-B (Recruitment & Conditions of service) Rules, (here-in-after referred to as the said rules), in rule 15.

(i) for sub-rule (1), the following sub-rule shall be substituted, namely:-

(2) The finally selected candidate shall be required to undergo two years training in a recognized Forest College to obtain the Diploma in Forestry. During the training, the trainees shall be paid each with salary and other allowances as admissible by the Government from time to time.

(ii) in the sub-rule (1), the clause (a), (b) & (c) shall be deleted.

(iii) the sub-rule (4) shall be deleted.
