Sub: - Digital monitoring of Afforestation activities under OFMS modules.



With reference to the memo cited above on the captioned subject, uploading of the correction spatial & attribute data of all the Nursery & Plantation sites (AR, ANR & Avenue sites) under different afforestation schemes for year 2024 using asset mapping module of OFMS is furnished below in respect of Sunabeda Wildlife Division, Nuapada for information and necessary action.

1. The current uploading status is enclosed herewith for yours ready reference. The following actions should be taken up for increasing the fruitfulness of monitoring & evaluation:
 - a) **Upload & update all the plantation sites-2024 selected for planting under all schemes.**
 - Uploaded all Plantation site 2024 i.e. ANR Plantation-13 nos. site & UTP-5 nos. site.
 - b) **Update the total no. of 18 months old seedlings to be planted along with name & number of species(in the Nursery Assets of 2023).**
 - Raising of 18 month seedling for Plantation 2024 (9 nos. site) name & number of species wise has been updated in OFMS Portal.
 - c) **Upload & update all the nursery sites raised during 2024.**
 - Raising of 18 month seedling raised during 2024 for Plantation 2025-2,50,000 nos. (9 nos. site) & Ficus seedling-30,000 nos. (4 nos. site) has been updated in OFMS Portal.
 - d) **Update all the plantation sites-2023 & 2024 with recent photographs.**
 - All Plantation sites 2023 & 2024 have been updated in OFMS Portal. Recent photographs will be update shortly.
 - e) **The wrongly uploaded/ incorrect assets of 2023 & 2024 should be rejected for better evaluation at this end.**
 - The wrongly uploaded/ incorrect assets of 2023 & 2024 has been rejected.


2. Further to access the removal of polypots from the current year plantation sites, a new field has been introduced in the plantation asset module in OFMS website. You are requested to edit & update the plantation assets for the current year 2024 by entering number of polypots & its weight in Kg on the OFMS website.
 - The Plantation assets 2024 will be updated entering number of polypots & its weight on the OFMS website.
3. For effective implementation of Plantation programme, all field Officer(RCCFs, DFOs, ACFs & ROs) are requested for frequent field visits and the inspection reports to be uploaded using OFMS mobile App (Inspection & Tour module).
 - Field visits and the inspection reports to be uploaded using OFMS mobile App.
4. Division-wise, nursery-wise & species -wise distribution of seedlings will be uploaded on the website for information of public to collect distribution seedling list of your Division by 25.06.2024 Positively as per the following proforma.
