NOTICE FOR CORRIGENDUM

Sub: Corrigendum regarding the tender call notice for providing manpower service to work under Kalahandi South Forest Division vide this office Notice No. 01 dated 09.05.2025.

This office tender call notice regarding Technical Bid in Appendix-D at Point No. 15 may be read as follows.

Earnest Money Deposit (EMD) @ 2% of Annual Contract Value (Rs.4,10,00,000/- approx.) i.e Rs. 8,20,000/- (Rupees eight lakh twenty thousand) only in shape of Bank TDR or Bank guarantee duly pledged to the Divisional Forest Officer, Kalahandi South Forest Division, Bhawanipatna, Dist.- Kalahandi. As per Odisha General Financial Rules, 2023, Rule no. 212 (i) the service provider registered under MSE is exempted from submission of Earnest Money Deposit (EMD). The service Provider should submit authenticated documents in support of registration under MSE to avail exemption.

This office tender call notice regarding financial terms and conditions in Annexure-II at Point no. 39 of financial terms and conditions may be read as follows.

The Service Provider shall execute an agreement with the DFO, Kalahandi South Forest Division, Bhawanipatna in line with the terms and condition laid down in Annexure - II and Appendixes A, B, C, D & E in the Tender Document and shall furnish a Performance Security Deposit @ 5% of the Contract value drawn at the time of Contract Agreement on any nationalized Bank at the place of tender in Shape of Bank TDR or Bank guarantee duly pledged to the Divisional Forest Officer, Kalahandi South Forest Division, Bhawanipatna, Dist.- Kalahandi for faithful implementation of the provisions of the agreement. The Bid Security of the finalized tenderer shall be retained at the Division, whereas the Bid Security of the remaining tenderers shall be returned to the respective tenderer after the completion of signing of the tender by the L-1 tenderer. As per Odisha General Financial Rules, 2023, Rule no 213 (iii), the service provider registered as Micro and Small Enterprises (MSEs) will not be considered as normal bidder and will be allowed to deposit concessional payment of performance security @25% of performance security prescribed for normal bidders.


