Applications are invited for engagement of **One Senior Research Fellow** with a monthly fixed remuneration of Rs.31,000/+16% HRA at Nabarangpur Forest Division, Nabarangpur, Odisha. The engagement is purely temporary and is initially for a period of one year which may likely to continue for next year(s) subject to satisfactory performance followed by execution of agreement.

Essential Qualification: Applicant must have consistent good academic career with **M.Sc. in Zoology/ Wildlife Biology/Life Sciences/ Animal Biotechnology/Microbiology/Forestry/ Biodiversity Conservation/Biochemistry/ Veterinary Science** or allied subject from a recognized university having at least 60% marks.

Desirable Experience: Experience in Wildlife, Bird or any wildlife census, data management in **MS-EXCEL, MS-Word, MS-Power Point** web- based tools and statistical data analysis will be preferred.

Age Limit: Upper age limit is **35Years as on 01.04.2025**, relaxable upto 5Years in case of SC/ST/SEBC candidates.

Duties of Senior Research Fellow:

- Senior Research Fellow will responsible for collection, maintaining and analyzing data following organizations management plans and procedures specifically but not limited to the following.
- Preparation and collection of Wild animal presence, Wild animal sign etc.
- Management, setting up and data collection of camera trap.
- Study of Wild animal behavior with related to Human Animal Conflict.
- Socio-economic study in Human Animal Conflict Areas.
- Digitalization and Inventory of Faunal Diversity of this division.
- Management of data generated from the available resources of this Division to create useful reports/returns.
- Website data management, online awareness/competition event management.
- Update the data in official sites of this division.


Other Conditions:

1. **Duration:** The employment of the Senior Research Fellow is for a period upto twelve (12)months. The engagement may be renewed on the basis of performance as decided by Divisional Forest Officer, Nabarangpur.
2. **Working hours:** The Senior Research Fellow will be expected to be on duty in Office opening to closing hours. The candidate may be required to work on off days and beyond duty hours on the discretion of the Divisional Forest Officer, Nabarangpur Forest Division with mutual agreement.
3. **Leave:** The candidate is allowed for 15days casual leave per year with prior permission of Divisional Forest Officer, Nabarangpur Forest Division.
4. **Remuneration:** Total remuneration per month will be Rs.31,000/+ 16% House Rent Allowance.
