After arrival in village Surangi the special messengers saw that the house owned by Sri Choudhury, Junior Assistant was locked. After some time a person named Srikant Choudhury who happens to be Cousin brother of Anil Kumar Choudhury, Junior Assistant has received the said letter with due signature (Copy Enclosed). Even after that Sri Choudhury, Junior Assistant has not joined in his official duties.

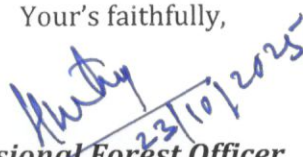
Therefore, you are requested to publish the said letters(Copy Enclosed) at least in three leading Odia Daily News paper as early as possible.

An early action in this matter is requested.

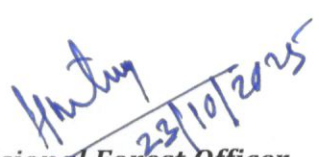

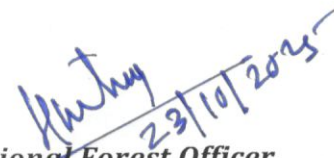

Sub: Stringent departmental action against employee Anil Choudhury, S/o Late Sanyasi Choudhury and to direct him to appear before IIC Jarada PS for examination withi 05 days and to co-operate in the process of investigation.

Sir/Madam,

In inviting a kind reference to the case and subject cited above I am to intimate to your good office that on the written report of one Lokanath Das of village Surangi, PS. Jarada, Dist. Ganjam this case has been instituted to the effect that on 05.10.2025 at about 02.15 PM while the complainant was available in his house one Anil Choudhury, S/o Late Sanyasi Choudhury along with his associates, Lipun Sahu, S/o Krushna Sahu, Lipun Panigrahy, S/o Trinath Panigrahy and others brought him forcible dragging by his collar on to the road and assaulted him brutally with an intention to kill him. The victim was rescued by some locals. He has got severe injuries on her face also he was getting bleeding from his nose. It is pertinent to intimate that the accused Anil Choudhury is a Gov. servant and he is working in forest department posted at DFO(North Division),Bhanjanagar. The accused Anil Choudhury is an anti-social having number of cases against him. He is creating a fearful environment and unrest in the locality. Being a govt. servant he is showing utmost indiscipline. Previously the said accused person had been forwarded to the Hon'ble court for his criminal acts and was in judicial custody. After causing attempt to murder on the victim Loknath Das he has absconded from the locality.

Under such circumstances, I pray to your good office to direct Anil Choudhury to appear before the Investigating Officer SI Samir Sekhar Jaisingh/IIC Jarada PS for his examination and to co-operate in investigation within 05 days as he has absconded soon after the incident.

Further requesting your good office to take stringent departmental action against him so also so not to grant any leave to him which will ultimately help him to flee from justice.
