





ADVERTISEMENT FOR THE POST OF "WILDLIFE VETERINARY OFFICER"
(Contractual)

The Divisional Forest Officer-cum-Wildlife Warden, Angul Forest Division invites applications from eligible and interested candidates for engagement of one (01) Wildlife Veterinary Officer for Mobile Veterinary Unit on a purely contractual basis for Angul Forest Division. The selection process shall consist of a written examination followed by an interview, scheduled to be held on 17.02.2026 (Tuesday) from 11.00 A.M. onwards at the Conference Hall, Office of the Divisional Forest Officer, Angul Forest Division. The prescribed application format, along with detailed terms and conditions of engagement, shall be available on the official websites www.angul.odisha.gov.in and www.odishaforest.in from 31.01.2026 to 16.02.2026.

Candidates willing to be considered for contractual engagement as Wildlife Veterinary Officer in Angul Forest Division may avail this opportunity by appearing in the written examination followed by interview, to be conducted by the Divisional Forest Officer-cum-Wildlife Warden, Angul, in accordance with the notified procedure.

Nature of Engagement

1. The post is purely contractual and does not confer any right for regular appointment.
2. Initial engagement shall be for a period of 06 (Six) months, extendable subject to satisfactory performance and availability of funds.
3. The engagement may be terminated at any time without assigning any reason, in case of unsatisfactory performance or administrative exigency.

Preference: Candidates possessing a **Master's degree and experience in wildlife management**, particularly in Elephant Management, Monkey Menace control and treatment of large herbivores, etc shall be given preference. *Submission of a brief write-up on previous professional experience along with the application.*

Objectives of Engagement:

1. To provide urgent and need-based veterinary healthcare to sick, injured and diseased wild animals.
2. To undertake daily surveillance and monitoring of wildlife health.
3. To attend and manage emerging and unprecedented disease outbreaks in wild animals.
4. To provide on-site diagnostic services for early disease detection.
5. To help mitigate human-wildlife conflict through awareness and timely intervention.
6. To support Anti-Depredation Squads in rescue, rehabilitation and release of wild animals.
7. To create awareness among livestock owners in forest fringe areas on bio-security measures.
8. To perform other departmental assignments as required.
9. To assist in formation and capacity building of Range-level Wildlife Rescue Teams through regular training programs in consultation with the DFO, Angul.

Veterinary services to be provided:

1. On-site treatment of wild animals at the place of detection.
2. Referral of complicated cases to the concerned Chief District Veterinary Officer / College of Veterinary Science & Animal Husbandry, OUAT, Bhubaneswar.
3. Early detection of communicable and non-communicable diseases.
4. Chemical immobilization, tranquilization and sedation of wild animals as per approved guidelines.
5. Curative treatment and post-treatment monitoring.
6. Review and monitoring of preventive vaccination programs of livestock and poultry in forest fringe villages.
7. Public and community health awareness activities.
8. On-the-spot examination of biological samples such as Fecal (F/S), Blood (B/S), Urine (U/S), and Skin Scrapings (S/S).
9. Collection of ante-mortem and post-mortem samples and their dispatch to referral laboratories.
10. Provision of veterinary healthcare during disease outbreaks, disasters and natural calamities.
11. Sensitization of farmers and local communities using suitable Information, Education and Communication (IEC) materials.

Roles and Responsibilities of Wildlife Veterinary Officer:

1. Overall responsibility for wildlife healthcare management and disease control within Angul Forest Division.
2. Referral and coordination with Block / Sub-Divisional / District Veterinary

- Dispensaries for advanced treatment.
3. Immediate response and reporting during disease outbreaks.
 4. Coordination with Animal Husbandry Department, local veterinary staff and PRI institutions during emergencies.
 5. Conducting post-mortem examinations of deceased wild animals and assistance in enquiry/investigation processes.
 6. Maintenance of date-wise performance records, including:
 - a. Name of livestock owner contacted
 - b. Nature of examination and observations
 - c. Verification of vaccination status of domestic animals
 - d. Awareness programs conducted
 - e. Samples collected and dispatched
 - f. Vehicle logbook
 - g. Any significant matter requiring reporting
 7. Any other duty assigned by the Divisional Forest Officer, Angul from time to time.

Area of Operation:

In view of increased morbidity and mortality of wild elephants and other wildlife, rising human-wildlife conflict, and growing anthropogenic pressures, deployment of a Mobile Veterinary Unit (MVU) is essential for Angul Forest Division.

The MVU shall conduct disease surveillance and wildlife healthcare services across Angul Forest Division. The Wildlife Veterinary Officer shall be the overall in-charge of the Mobile Veterinary Unit (MVU) for Angul Forest Division. In case of emergency, services may be extended to adjacent forest divisions for optimal utilization of departmental resources.

Job Description and Details:

1. This is a resident post; the selected candidate must reside at Angul.
2. The officer shall work under the administrative control of the DFO, Angul Division and as per exigencies of Angul Circle
3. The officer shall active, energetic, willing to move in and around Forest area.
4. The maximum age limit for application is less than 65 years.

Monitoring & Supervision:

1. Regular concurrent monitoring and supervision will be done by the DFO-cum-Wildlife Warden with assistance and active role of ACF.
2. Work done certificate has to be submitted at the end of every month by the Veterinarian, which has to be verified by the ACF & passed by the DFO before processing of the remuneration and associated bills of expenditure if any.

The selection process shall consist of the following stages:

1. Written Examination (Objective Type – MCQs):
 - Maximum Marks: 60
 - The written examination shall comprise Objective Type Multiple Choice Questions (MCQs).
2. Interview:
 - Maximum Marks: 40

Candidates shall be ranked strictly on the basis of marks obtained in the Written Examination (MCQs). Based on merit, only the top five (05) candidates shall be shortlisted and called for the Interview to be conducted on the same day in the afternoon.

The final merit list shall be prepared out of a total of 100 marks (Written Examination – 60 marks and Interview – 40 marks).

The merit list so prepared shall remain valid for a period of one (01) year from the date of declaration of results and shall be maintained as a reserve panel, to be operated as and when required, subject to administrative exigencies.


