Applications are invited for engagement of One GIS Specialist -cum- Drone Operator with a monthly fixed remuneration of Rs. 40,000/- at Divisional Forest Officer, Kalahandi North Forest Division, Bhawanipatna, Kalahandi, Odisha. The engagement is temporary and is for a period of eleven months i.e. from May 2025 to March 2026.

Candidates interested in contractual engagement in Divisional Forest Office, Kalahandi North Division may avail the opportunity through walk-in interview to be conduct at Divisional Forest Office, Kalahandi North Division. This post is purely contractual and the engagement can be terminated at any time in case of unsatisfactory performance/nonavailability of funds or any other reasons. The remuneration per month will Rs.40,000/ and will be Paid from Site-Specific Wildlife Conservation Plan under CAMPA APO 2025-26.

Essential Qualification: Candidate must have a Master's degree in natural sciences or earth sciences. Bachelor's degree in natural sciences or earth sciences with 1-2 year work experience may also be considered. Candidates must have worked with GIS software, programming languages and operation of drones and camera traps. A letter of experience regarding the same must be attached.

Candidates having prior experience of working with wildlife/ knowledge of Bio Statistics/ Knowledge of image processing shall be preferred.

Age Limit: Age no bar.

Duties of GIS Specialist -cum- Drone Operator:

- GIS Specialist -cum- Drone Operator will responsible for collection, maintaining and analyzing data following organizations management plans and procedures specifically but not limited to the following.
- Collection of Wild animal presence, Wild animal sign etc. from the field through drone.
- Management, setting up and data collection through camera trap.
- Processing and creating database of collected data.
- Analyzing the collected data with respect to different objectives.
- All the data shall be the exclusive property of government and cannot be used otherwise without permission of Divisional Forest Officer, Kalahandi North.
- Study of Wild animal behavior with respect to Human Animal Conflict.
- Socio-economic study in Human Animal Conflict Areas.

- Digitalization and Inventory of Faunal Diversity of this division.
- Management of data generated from the available resources of this Division to create useful reports/returns.
- Prepare maps on Google Earth related to Site Specific interventions like plantation., SMC works, water bodies, WHS etc.
- She/he shall assess the success of Site-Specific plans and recommend any revision or modifications that are required.

Other Conditions:

1. Duration: The employment of the GIS Specialist -cum- Drone Operator is for a period up to Twelve (12) months, subject to satisfactory performance.

2. Working hours: The GIS Specialist -cum- Drone Operator will be expected to be on duty in Office opening to closing hours. The candidate may be required to work on off days and beyond duty hours on the discretion of the Divisional Forest Officer, Kalahandi North Forest Division.

3. Leave: The candidate is allowed for 11 days casual leave per year with prior permission of Divisional Forest Officer, Kalahandi North Forest Division.

4. Remuneration: Total remuneration per month will be Rs. 40,000/ - consolidated.

5. The Office is under no obligation to continue the engagement and may discontinue the engagement with one (1) month prior notice, without assigning any reason thereof.

The GIS Specialist -cum- Drone Operator will not use or share any data related to Divisional Forest Officer, Kalahandi North Forest Division to outside the organization without prior permission from the authority.
