Divisional Forest Officer, Athgarh Forest Division invites Application from interested candidates for engagement of One Wildlife Veterinary Officer in Athgarh Forest Division. The interview is scheduled on 16.04.2025 at 11:00 AM through virtual mode. Candidates interested in the contractual engagement as Wildlife Veterinary Officer in Athgarh Forest Division may avail the opportunity through virtual interview to be conducted by Divisional Forest Officer, Athgarh. This post is purely contractual and the engagement can be terminated at any time in case of unsatisfactory Performance/ non-availability of funds or any other reasons. Initial engagement will be for 12 months.

Aim:

Wildlife Veterinary Officer will help immensely providing in-situ healthcare services to sick and injured wild animals requiring immediate attention and treatment. The veterinarian will also be helpful in wildlife conflict management in many ways by providing healthcare services during disease outbreaks, natural calamities and public emergency.

Veterinary services to be provided:

- 1. Treatment of different cases of wild animals at the site of detection and further follow up.
- 2. Referral of complicated cases to the concerned Chief District Veterinary Officer/ College of Veterinary Science and Animal Husbandry, OUAT, Bhubaneswar/ zoo/ Rescue centres.
- 3. Early detection of communicable and non-communicable diseases.
- 4. Tranquilization/ sedation of wild animals in case of emergency.
- 5. Curative treatment to sick and injured wild animals.
- Reviewing and monitoring preventive vaccination of livestock and poultry in forest fringe areas.
- 7. Creation of public health awareness.
- 8. On spot examination of Faecal Sample (F/S), Blood Sample (B/S), Urine Sample (U/S), Skin Scrapping (S/S).
- Collection of both ante-mortem and post-mortem samples and their subsequent delivery to referral laboratory for further diagnosis.
- 10. Provision of healthcare services at times of disease outbreaks and natural calamities.
