

**Terms of Reference for re-engagement of one retired Conservator of Forests as a Consultant in CAMPA Wing, O/o the PCCF & HoFF, Odisha**

Applications in the prescribed proforma (as per Annexure) are invited from the eligible candidates for his/her engagement as a Consultant in CAMPA Wing, O/o the Principal Chief Conservator of Forests & HoFF, Odisha, Bhubaneswar as per the details given below.

**Name of the Post :** Consultant – **Group-A (Level-17)** of ORSP Rules, 2017 or analogous scale.

**Qualification/Eligibility :** (i) Retired Government servant of Level-17 of ORSP Rules, 2017 or analogous scale having minimum 5 years working experience in State Forest Head Qrs./ State Wildlife Hqrs. (ii) Candidate should have proficiency in preparation of CAMPA APO and well conversant with CAF Acts & Rules, Preparation of CAMPA Budget & Accounts etc. (iii) He/ She should not have any Deptt. proceedings, vigilance or criminal cases during his/her service period.

**Age :** The age of the applicant should not be more than 65 years on the date of publication of the Advertisement & he/she should be physically fit.

**Remuneration:** The person to be engaged as a Consultant shall be paid consolidated remuneration of Rs.50,000/- (Rupees Fifty Thousand only) per month. No other facilities like accommodation, House Rent, conveyance are admissible as per Govt. of Odisha, Finance Dept. O.M No. 24533/F Dated 29.09.2022.

**Work Assignment :** The Consultant is to render his/her service under the guidance of Chief Executive Officer, O/o-the State Authority, CAMPA. He shall prepare Annual Plan of Operation, Annual CAMPA Budget and Accounting, Monitoring of CAMPA activities for Forests and Wildlife. He will assist in conducting meeting of statutory bodies of State Authority, CAMPA, various internal correspondence with National Authority, CAMPA and preparation of reply to the Parliament/Rajya Sabha Questions and Queries of Government and other responsibilities as per instruction of CEO, CAMPA and PCCF & HoFF Odisha.

**Terms and conditions :**

- i. Applicant against whom departmental proceedings/ criminal cases are contemplated/ pending or who have been penalized for misconduct are not eligible for consideration.
- ii. The engaged officer is subject to Odisha Government Servants Conduct Rules, 1957 and liable to be proceeded against for his/her misconduct, omissions and commissions as per the provisions under the Odisha Civil Service Pension Rules, 1962.
- iii. The engagement can be terminated with one month notice from either side.
- iv. The consultant has to attend office on all working days of the Government and entitled for 15 days leave during the year.
