

**Terms of reference for engagement of one retired Deputy Conservator of Forest as Consultant in CAMPA Wing, O/o the PCCF & HoFF, Odisha**

\* Applications in the prescribed proforma(as per Annexure) are invited from the eligible candidates for his/her engagement as Consultant in CAMPA Wing, O/o the Principal Chief Conservator of Forests & HoFF, Odisha, Bhubaneswar as per the details given below.

**Name of the Post :-** Consultant – **Group-A (Minimum Level-12)**  
Under ORSP Rules, 2017.

**Qualification/Eligibility:-** Retired Dy.CF having minimum 5 years or more experience working in Territorial Wing, Plantation Activities, Working Plan Preparation, Monitoring & Evaluation and Forest Accounting shall be preferred.

**Age :-** The age of the applicant should not be more than 64 years of age as on the date of Advertisement & he/she should be physically fit.

**Remuneration:-** The person who will be engaged as Consultant will be paid consolidated remuneration of Rs.35,000/- (Rupees Thirty-Five Thousand) only per month. Facilities like transport and residential accommodation will not be provided as per Govt. of Odisha, Finance Deptt., O.M No.24533/F Dt.29.09.2022.

**Work assignment :-** The Consultant will be engaged in the CAMPA Wing O/o the Principal Chief Conservator of Forests & HoFF, Odisha to assist in preparation of Annual Plan of Operation, Analysis of Physical & Financial progress of CAMPA activities taken up by Implementing Divisions, evaluation and monitoring of Forestry & Wildlife activities, reply to Assembly/ Parliament Questions, compliance to the queries of Govt./ National Authority or other higher authority/ or any other work assigned by CEO, State Authority, CAMPA.

**Terms and conditions :-**

- i. Applicants against whom departmental proceedings/ criminal cases are contemplated/ pending or who have been penalized for misconduct during the period of preceding 05 (five) years of retirement are not eligible for consideration.
