





Terms of reference for engagement of one retired Statistical personnel in the vacant post of Asst. Statistical officer in 5F Stat. Section of ME&IV Wing of O/o the PCCF & HoFF, Odisha.

Application in the prescribed proforma (as per Annexure) are invited from the eligible candidates for his/her engagement as Consultant in 5F (Stat.) Section, O/o the Principal Chief Conservator of Forests & HoFF, Odisha, Bhubaneswar, as per the details given below.

Name of the Post :- One Consultant – (Group-B in Level 9) Under ORSP Rules, 2017. (Statistical personnel against the vacant post of Assistant Statistical Officer)

Qualification/Eligibility:- Retired Statistical personnel having minimum 5 years or more experience in Forest Department.

Age:- The age of the applicant should not be less than 50 years and not more than 64 years of age as on the date of Advertisement & he should be physically fit.

Remuneration:- The person who will be engaged as Consultant should have worked in Level 9 under ORSP Rules, 2017 will be paid remuneration of **Rs.20,000/-** (Rupees twenty thousand) only per month and no other allowance like D.A., H.R.A., T.A., Medical reimbursement etc. will be admissible. Facilities like transport and residential accommodation will not be provided as per Govt. of Odisha, Finance Deptt. O.M. No.24533/F Dt.29.09.2022.


Work assignment:- The Consultant will be engaged in the 5F (Stat.) Section of (ME&IV) Wing, O/o the Principal Chief Conservator of Forests & HoFF, Odisha to assist matters relating to Assembly Matters, Parliament Matters, FSI Matters, Road Lengths, Annual Activity Reports, all RTI Matters, Compilation of E-Abhijoga Petitions, Forest Statistics of Odisha, Environmental Statistics, Maps and Notifications, DLC Matters, Compliance of Forest Area of the State/Division/Circle, Economic Survey Report & Compliance of AAR Chapter.

Term and condition:-

(i) Applicants against whom departmental proceedings/criminal cases are contemplated/pending or who have been penalized for misconduct during the period of preceding 5 (five) years of retirement are not eligible for consideration.

(ii) The engaged officer is subject to Odisha Government Servants Conduct Rules, 1957 and are liable to be proceeded against for his misconduct, omissions and commissions as per the provisions under the Odisha Civil Service Pension Rules, 1962.

(iii) The engagement can be terminated at any time by the competent authority owing to unsatisfactory performance of the Consultant engaged by giving one month's notice. On the contrary, if any consultant desires to resign, he shall do so by giving one month's written notice to the competent authority.


