- b. All the nominated trainee ACFs are within permissible age limit for admission within the ambit of Recruitment Rules, 2013 of Odisha State.
- c. Instruction and information for the trainees issued by CASFOS, Coimbatore has been disseminated to these trainees.
- d. Action is being taken training cost @ Rs. 11 lakhs per trainee ACFs for two years in respect of above 19 trainee ACFs shortly.
- e. Mr. Hitesh Mishra has successfully cleared the competitive examination for recruitment by Odisha Public Service Commission and DFE, Dehradun has recommended for relaxation vide Letter No.4-213/Trg.I/DFT-2026/522-27 dated 03.06.2026 to DIG(RT), Government of India, MoEF & CC, New Delhi under intimation to CASFOS, Coimbatore.
