





1. The Divisional Forest Officer, Jharsuguda Forest Division on behalf of Governor of Odisha invites **Percentage Rates Bids in Double cover system** in on-line mode system as detailed in the table from the class of eligible contractors as mentioned in **Column -05 (Five)** registered with the State Govt. and contractors of equivalent Grade/ Class registered with central Govt. / MES / Railways for execution of **Civil Works**. The proof of registration from the appropriate authority shall be enclosed along with the bid. The successful bidder who has not registered under State Government has to register under the State PWD in appropriate class of eligibility before signing of the agreement.

4. The bidder shall transfer online towards cost of bid documents for amount specified for the work in the table at Sl.No. 1 to 10 (Col-7) above for each bid respectively through a process as mentioned the DTCN.
5. The Bidders shall transfer online the Earnest money deposit / Bid Security of the amount specified for the works on the table column 4 above as part of its bid through a process as mentioned in DTCN.
6. The Bid documents will be available in the website: www.tenderodisha.gov.in / www.dfojharsuguda.org/ www.jharsuguda.nic.in. from **09.11.2023 to 20.11.2023** for online bidding.
7. The bidders must possess compatible Digital Signature Certificate DSC Class-II or Class-III.
8. Bids Shall be received only ONLINE from dt. **10.11.2023 at 11.00 AM upto 20.11.2023 at 05.00 PM except from those contractors who have failed to carryout construction works after finalization of their Tenders as L1 and L2 Bidders for a period of three years from the date**


of assignment of works to them as L1 and L2 Bidders and as such their Tender papers in this Division will not be entertained and will be automatically rejected.

9. Bids received online shall be opened at **11.30 AM on dated. 27.11.2023** in the Office of the Divisional Forest Officer, Jharsuguda Forest Division in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. And the financial bids shall be open after the Evaluation of Technical Bids.
10. **Please, submit the required documents which are clear and visible, otherwise your application will be rejected. If you are unable to furnish visible documents you may also furnish the hard copies of the required document.**
11. Rate quoted by the contractor shall be excluding of GST. The GST as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice.
12. The successful bidder who has quoted less bid price / rate less than estimated cost put to tender as per **Works Deptt. Govt. of Odisha Office Memorandum No. 4559 dt.05.04.2021 (details attached in DTCN)** shall have to furnish i.e as additional performance security (APS) in shape of Bank Guarantee/ TDR Pledged in favour of Divisional Forest Officer, Jharsuguda Forest Division of concerned Division Within 7 days from date of intimation otherwise the bid shall be cancelled & security deposit shall be forfeited further, proceeding of blacklisting shall be intimated against the bidder.
13. Engineering contractors who are desirous to avail the facility of exemption of EMD / ISD are required to submit the scan copy of affidavit along with bid document to the effect that he / she had not yet availed the facility during current financial year as per codal provision.
14. The SC/ST contractors willing to avail the facilities as fixed by Govt. will submit scan copy of the affidavit for the same along with tender document; otherwise, they will not be entitled to avail such facilities.
15. Other details can be seen in the bidding documents.
16. Detailed information as contained in D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
17. Any tenderer desirous to avail any facility as per certain circular/order of Government have to apply for the same in writing along with the tender paper. Claim at the time of opening of tender or later will not be entertained.
18. If any of the intending bidders wish to withdraw from participation in the bid, He/She can freely **withdraw** from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant Codal practice will be taken against him/her.



The DIVISIONAL FOREST OFFICER, JHARSUGUDA FOREST DIVISION, JHARSUGUDA on behalf of Governor of Odisha invites **Percentage Rate bids** in double cover system in **online mode** for the construction of civil works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (Five) registered with the State Governments and Contractors of equivalent Grade / Class Registered with Central Government for execution of Civil Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work.
2. Class of Contractor: As per Column -5 of Annexure.
3. Time for Completion: As per Column-6 of Annexure.
4. Tender Paper Cost : Tender paper cost submitted Online as per Col-7 of Annexure
5. E.M.D. required. : As per the Works Department Memorandum No 8943 dtd 18.03.2021, the bidder must submit "1% of Tendered Amount" in lieu of furnishing EMD at the time of submission of Bid as per format enclosed in DTCN.
6. Mode of Submission of tender. : Tender should be submitted through online mode only.
Tender to be submitted in two separate folders as detailed below containing the following:-

- a) Tender Paper Cost
- b) EMD (1% of Tendered Amount)
- c) Annexure-I to Annexure-X with all related documents.
- d) Unequivocal acceptance of all the Terms & Conditions & technical specifications of the bidding documents duly seal & signed by the tenderer.

Envelop 2: The tender document issued to the bidder, with rates duly filled in, signed & stamped in all pages. There should be no condition in this envelope which will otherwise make the bid of the tenderer liable to be cancelled.

8. Bid documents consisting of qualification information and eligibility criteria of bidders, plans, specifications, drawings & the schedule of quantities of the various classes of work is available in website www.dfojharsuguda.org/www.jharsuguda.nic.in/www.tenderodisha.gov.in.
9. The bid for the work shall remain valid for a period of ninety (90) days from the date of opening of bids. If any Bidder / Tenderer withdraw his bid / tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited and procedure for blacklisting will be initiated.

11. Tenderer represented through power of attorney holder should ensure that the power of attorney is duly signed and identified through an affidavit from first class Magistrate containing the photograph of both the license holder and the person to whom the power of attorney is given unless the tender will be considered for rejection.
12. If the office happens to be closed due to subsequent declaration as holidays by Government or local authority on the date of opening as specified above, tenders will be opened on the immediate next working day at the same specified time and venue.
13. The successful Tenderer should produce all the original documents within 5 days of receipt of intimation for verification.
14. **Exemption of EMD.** To avail the exemption of EMD, the intending Engineering Contractor are required to produce an affidavit along with the tender paper to the effect that he has not availed the exemption of EMD for 3 (three) works during current financial year.
15. **Performance Security** shall be obtained from the bidders as per Works Department memorandum no 5992 dtd. 27.04.2021 in shape of TDR, POTD, POSB, NSC & KVP and EMD& ISD in shape of POTD, NSC, POSB & KVP pledged in favour of the Divisional Officer, JHARSUGUDA within

seven days of issue to LOA.

16. The Additional Performance Security (APS) shall be obtained from the bidders as per Works Department memorandum no 4559 dtd. 05.04.2021 in shape of TDR, POTD, POSB, NSC & KVP and EMD & ISD pledged in favour of the Divisional Officer within seven days of issue to LOA otherwise the bid shall be cancelled and the EMD shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.
