INVITATION FOR BIDS THROUGH E-PROCUREMENT

1. The Divisional Forest Officer, Khariar Division, Khariar on behalf of Governor of Odisha invites Percentage Rates bids in Single Cover in online mode for the Construction works as detailed in the table, from the class of eligible contractors as mentioned in column -6 registered with the State Govt. and contractors of equivalent Grade/Class registered with central Govt./MES/Railway for execution of Civil Works. The proof of registration from the appropriate authority shall be enclosed along with the bid. The successful bidder who has not registered under State Government has to register under the State PWD in appropriate class of eligibility before signing of the agreement.
2. The bidders may submit bids for the following works.

4. The Bid documents will be available in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from 11.00 A.M. of dated 25.11.2024 to 5.00 P.M. of dated 04.12.2024 for online bidding.
5. The bidder must possess a compatible Digital Signature Certificate (DSC) of Class-II & Class-III.
6. Bids shall be received only online on or before dated 04.12.2024 up to 5.00 P.M. **of dated except from those contractors who have failed to carryout construction works after finalization of their Tenders as L1 and L2 Bidders for period of three years from the date of assignment of works to them as L1 and L2 Bidders and as such their Tender papers in this Division will not be entertained and will be automatically rejected.**

7. Bids received online shall be opened at 11.00 A.M. dated 05.12.2024 in the Office of the Divisional Forest Officer, Khariar Division in presence of the bidders who wish to attend. Bidders who participate in the bid can witness the opening of bids after logging to the site through their DSC. If the office happens to be closed on the last date of sale on receipt of the bids as specified, the bids will be opened on the next working day at the same time and venue.  
**And the financial bids shall be open after the Evaluation of Technical Bids.**
8. Please, submit the required documents which are clear and visible, otherwise your application will be rejected. If you are unable to furnish visible documents you may also furnish the hard copies of the required documents.
9. Rate quoted by the contractor shall be excluding of GST. The GST as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice.
10. The bidder shall have to furnish a security declaration as per the Office Memorandum No. 8943 dated 18.03.2021 of Finance Department, Government of Odisha in lieu of the bid security in the format annexed, form of bid security declaration along with the bid.
11. The successful bidder who has quoted less bid price/ rate less than estimated cost put to tender as per **Work Department Office Memorandum No.4559 dated.05.04.2021 as given in DTCN** shall have to furnish i.e. as Additional Performance Security (APS) in shape of STDR pledged in favour of Divisional Forest Officer, Khariar Forest Division of concerned Division within 7 days from date of intimation otherwise the bid shall be cancelled & Security Deposit shall be forfeited further, proceeding of black listing shall be intimated against the bidder.
12. Engineering contractors who are desirous to avail the facility of exemption of EMD/ISD are required to submit the scan copy of affidavit along with bid document to the effect that he / she had not yet availed the facility during current financial year as per codal provision.
13. The SC/ST contractors willing to avail the facilities as fixed by Govt. will submit scan copy of the affidavit for the same along with tender documents, otherwise, they will not be entitled to avail such facilities.
14. Tenders in complete shape should be uploaded with a valid registration certificate, PAN Card, GST Certificate, T.P. Cost, and Affidavit in schedule-F in the prescribed format.
15. This is a time-bound work, to be completed within the stipulated period. The respective bidders are advised to study the scope of work and survey the site for constraints if any and assess their bid capacity and capability before submitting their tenders.
16. Other details can be seen in the bidding documents.
17. The authority will not be held responsible for any technical snag or network failure during online bidding.
18. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
19. The Addendum / Corrigendum if any will be hosted in the website only.
