





Sealed tender in the prescribed form to be eventually drawn-up in Standard Forest Department Form P-01 (Percentage Rate Bids) in conformity with the Detailed Tender Call Notice is invited by the Divisional Forest Officer, Paralakhemundi Division, Paralakhemundi on behalf of Governor of Odisha in **SINGLE COVER SYSETM** only on **"ONLINE"** for the construction of works as detailed in the table below from **"D" & "C" Class Contractors** registered with the State Government and contractors of equivalent grade/Class registered with Central Government / MES /Railways for execution of Civil Works, on production of definite proof from the appropriate authority. The bidders may submit bids for any or all of the following works separately.

3. The bidder shall transfer online towards cost of bid documents for amount specified for the work in the table at Sl. 1 to 7 (Col.-6) above for each bid respectively through a process as mentioned in the DTCN.
4. The bidder shall produce "Bid Security Declaration" towards Earnest Money Deposit / Bid Security as per Sl. 1 to 7 (Col.-5) of the table above as part of its Bid through a process as mentioned in the DTCN.
5. The Bid Documents will be available in the website: <https://tenderodish.gov.in> / www.odishaforest.in / www.gajapati.odisha.gov.in from **10.00 A.M of dated 16.12.2024 to 05.00 P.M of dated 26.12.2024** for online bidding.
6. The bidders must possess compatible Digital Signature Certificate DSC of Class-II or Class-III.
7. Bids shall be received only **"Online"** on or before **05.00 P.M of dated. 26.12.2024.**
8. Bids received online shall be opened at **11.30 A.M on dated 27.12.2024** in the Office of the Divisional Forest Officer, Paralakhemundi in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
9. Engineering contractors who are desirous to avail the facility of exemption of EMD/ISD are required to submit the scan copy of affidavit along with bid document to the effect that he/she had not yet availed the facility during current financial year as per codal provision.


