- 2) **The Bidders should be deposited online 1 % Bid Security / EMD of tender cost as per Letter of Works Department.**
- 3) The Bid documents will be available in the website www.tendersodisha.gov.in from **18:00 Hours of 11.12.2025 to 13:30 Hours of 20.12.2025.**
- 4) The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class III or Class IV.**
- 5) **Bids shall be received only "Online" on or before 13:30 Hours of Dtd.20.12.2025.**
- 6) Bids received "online" shall be opened **at 11:30 Hours on dt. 22.12.2025** in the office of the Divisional Forest Officer, Redhakhhol Forest Division, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- 7) The items covered in **Clause No-122 of DTCN** for roads and building works are required as essential criteria for eligibility for qualification, Checklist should be duly filled in.
- 8) The bidder shall transfer online the cost of bid documents as shown in **column-7** above through a process as mentioned in-DTCN.
- 9) Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
- 10) This notice is to be read with all the Clauses / addendum to the "Procedure to participate in online bidding". Any corrigendum / Addendum will be displayed in the website www.tendersodisha.gov.in only.
- 11) If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.
