
**(A) Eligibility Criteria:-**

1. The Tenderers shall submit the information in the prescribed format only.
2. The Tender Paper will be available in the office of the Divisional Forest Officer Mangrove Forest Division (WL), Rajnagar on any working day for Rs. 1,000/- from Dt. 05.09.2024 to Dt.18.09.2024 -within official hour (10:00 AM to 5:30 PM) & on our website. The tenderers who download the document from web site will require to submit Rs. 2,000/- in shape of Demand Draft issued by Central Bank of India, Sanabada Gopalpur, Rajnagar drawn in favor of "Divisional Forest Officer, Mangrove Forest Division (Wildlife) Rajnagar" payable at Rajnagar along with quotation paper, otherwise the quotation is liable to rejection.
3. Copy of Aadhar Card of the person concerned who signs the Tender paper.
4. Copy of PAN Card and copies of the Income Tax Returns duly filed for the last 3 years(Relaxable for startups).
5. Copy of Audited Balance Sheet of last 03 years(Relaxable for startups).
6. Copy of GST Registration Certificate must be submitted along with Tender along with copy of up-to-date GST return.
7. Copies of Work Orders/Documentary Proof in respect of supply of GI Chain Link Mesh to Govt. Sector & Non-Govt. Sector for last 2 years.
8. The Tenderers shall deposit Rs. 50,000/- (Rupees Fifty Thousand) only towards the Earnest Money Deposit in the form of an A/c Payee Bank Draft issued by Central Bank of India, Sanabada Gopalpur, Rajnagar drawn in favor of "Divisional Forest Officer, Mangrove Forest Division (Wildlife), Rajnagar" payable at Rajnagar along with Tender Paper. This draft will be returned to all unsuccessful bidders without any interest and in the case of successful bidder, the amount will be refunded without any interest only after successful completion of supply. Tender Papers without EMD will not be considered.
9. Copies of Partnership Deed/Incorporation Certificate in case of Private Limited Companies.
10. Authorization Letter/Copy of Resolution in favour of particular Partner/Director to sign the Tender and participate the bid must be submitted with Tender.
11. The participating tenderer shall supply sample piece (0.25mtr x 0.25mtr) to this office on or before the last date opening of Technical BID either by post or by Special messenger. The Sample shall be accompanied by Test report (Mesh size, diameter, width, Mass of Zinc Coating-120 GSM, tensile strength) only from any one of the National Test House. Without the NTH report the bidder shall be disqualified in the technical Bid. The report shall be issued only after the BID publishing date.
12. A declaration by the tenderer that the documents submitted by him are true to the best of his knowledge and in case any thing contrary arises in future, the Tenderer shall remain solely liable for that.
13. An Affidavit by the Tenderer to be declaring & effect that, till date, the Firm/Company/Enterprises has not been black listed by the Govt. Departments or any Govt. Organization and no criminal case is pending against the firm or its owners/Partners/Directors.
14. The Price quoted should be per station and inclusive of all charges, taxes, delivery to different Ranges of Mangrove Forest Division (Wildlife), Rajnagar.
15. Any other documents related to this product can be submitted along with Tender.
16. Inter State bidders may not participate in bidding process as per the Govt. of Odisha MSME, Department Notification No. MSME-IPE-MISC.-0060-2019/566/MSME, date- 24.01.2024.



## **B) Terms and Conditions of the Tender:**

1. The supply will be complete within 15 days of the Purchase Order.
2. The Tenderer must have sound and wholesome experience.
3. The Tenderer shall have to submit Tenders in two separate sealed envelopes, one for "Technical" and other for "Financial" bids.
4. Technical bid documents for all required documents as per SQCN will be placed in one Envelope super scribing on the envelope as "Technical Bid "& "Supply of GI Chain Link Mesh". **The envelope must be securely sealed.**
5. Financial Bids must be in the prescribed format filled in all respect of this notice and it will be placed in one envelope super scribing on the envelope as "Financial Bid "& "Supply of GI Chain Link Mesh". **The envelope must be securely sealed.**
6. In the financial bid, the rates must be specified with item-wise break-up and rates per Sq. Mtr. inclusive of all taxes and levies.
7. These two envelopes containing Technical Bids and Financial Bid, should be placed in one envelope super scribing on the envelope as "**Tender for Supply of GI Chain link Mesh**".
8. Financial Bids of only those bidders who shall qualify in the technical bid criteria will be opened. In case of unsuccessful Tenderers, the financial bid un-opened & EMD will be returned back after finalization of Tender process.
9. Documents which are not submitted inside the bids will not be added or entertained at the time of opening of the bids.
10. Only Securely Sealed Tenders should reach the bid accepting desk of Office of Divisional Forest Officer, Mangrove Forest Division (Wildlife), Rajnagar through Registered Post/Registered Couriers / Speed Post on or before 12.09.2024 (5 PM).
11. No reasons for delay in delivery of bids in office of Divisional Forest Officer, Mangrove Forest Division (WL), Rajnagar through post or courier shall be entertained. **After opening of the technical bid, the Tender Papers will be technically checked by the committee to be constituted by the Divisional Forest Officer, Mangrove Forest Division (Wildlife), Rajnagar.**
12. Failure to present the Originals at the time of Opening the Technical Bid, shall lead to the disqualification of Technical Bid.
13. Any form of canvassing shall lead to disqualification in bidding.
14. The Divisional Forest Officer, Mangrove Forest Division (WL), Rajnagar reserves the absolute rights for accepting or rejecting any of the bids without any further notice or intimation to the Tenderers assigning any reasons. He reserves all right to alter any of the terms and conditions as deemed proper in the interest of the Govt.
15. The Successful Tenderers shall be required to enter an agreement with the undersigned for supplying within 15 days.
16. The material supplied by Success Tenderers shall be sent by the undersigned to any Govt. Approved Lab / NTH for testing of standards. Only upon satisfactory test report with regards to G.I. Chain Mesh, confirming to the specifications as per tender document, the consignment will be accepted and up till then the material will be at the complete risk / cost of the supplier / firm and the undersigned will in no way be financially / physically responsible for the upkeep of the material.
17. The successful Tenderers has to deposit 10% of the bid amount towards Performance Security. On successful completion of the work, the said amount will be returned to the successful Tenderer within six months of the successful Completion. The Performance Security should be furnished in the form of Demand Draft from any nationalized bank in favour of "**Divisional Forest Officer, Mangrove Forest Division (Wildlife), Rajnagar**".
18. As per the guidelines of the Income Tax Department, TDS at the applicable rate shall be deducted from the supplier at the time of payment.
19. GST as applicable shall be deducted from the supplier at the time of payment.
