SHORT TENDER NOTICE

The Divisional Forest Officer, Subarnapur Forest Division invites **sealed tenders** under **the Double Cover System**, strictly in "**OFFLINE**" mode, for the procurement of 1 (One) No. **Thermal UAV Quadcopter**, as specified in **Annexure-I**, for use in the Subarnapur Forest Division.

Tenders are invited from **eligible Firms/Vendors/Suppliers** who are registered with the **State Government, Central Government, Military Engineering Services (M.E.S.), or other recognized licensing authorities** for the supply of Thermal UAV Quadcopters.

Interested bidders must meet the **eligibility criteria and possess the required qualifications** for supplying the item as detailed below.

PRE-REQUISITE FOR SUPPLY OF MATERIALS

- 01.The Bidders / Vendors / Suppliers should have valid GST Registration with the competent authority.
- 02.The Bidders / Vendors / Suppliers should have Permanent Account Number (PAN) registered with competent authority.
- 03.The bidders must submit a proof of identify (Voter ID, Aadhaar Card, Driving Licence).
- 04.The Bidders / Vendors / Suppliers have authorization from the concerened Dealer / Firm / Company to supply the goods / materials.
- 05.The Bidders / Vendors / Suppliers must have a valid Bank Accounts number in any Bank.
- 06.The Bidders / Vendors / Suppliers must have operational area within the State of Odisha.

TERMS AND CONDITIONS

01. Offering of best price by firms / suppliers / supply house / manufacturers should be submitted in the Prescribed Form provided in the Tender documents.
02. The bidder shall have to deposit of tender paper cost @2000/- (Rupees Two Thousand only) for participation in the bid in shape of Bank Draft/ Banker's Cheque etc. in favour of Divisional Forest Officer, Subarnapur Forest Division. The Tender Paper cost is non-refundable in nature.

05. Bids received shall be opened at 11.00 hours on 12.09.2025 in the Office of undersigned in the presence of the bidders who wish to attend. Bidders who participate in the bid can witness the opening of bids.
06. Bidders are to submit the TECHNICAL BID (**ANNEXURE-II**) and FINANCIAL BID (**ANNEXURE-III**) in a two Separate Sealed Cover quoting price in FINANCIAL BID for the article intended to supply out of the list in **ANNEXURE-I** and both the cover to be enveloped in one Cover and dropped in the Drop Box or sent through the Postal or courier service on or before 05.00 PM of 11.09.2025.
07. The Authority will not be held responsible for any postal delay or other inconvenience during bidding process.
08. The authority reserves the right to cancel any or all bids without assigning any reason thereof.
09. The intending bidders are required to furnish their e-mail address and cell phone number in order to inform them any message relating to the tender.
10. Simply quoting lower prices shall not automatically entitle any bidder to be awarded NDS the contract. The Tender Evaluation Committee reserves the discretionary right to finalize the bid based on the overall quality, specifications, and brand reputation of the offered item.
11. Bidders are required bring the sample at the time of evaluation and demonstrate its functionality, if required.

12. The bidders/ vendors/ supplier will have to attend the office of the undersigned on the date intimated later on for checking of quality assurance by the committee.
13. In case any bidder/vendor/supplier intends to obtain the tender documents directly from the office of the Divisional Forest Officer (DFO), Subarnapur Forest Division, they must submit a Demand Draft (DD) of ₹2000/- (Rupees Two Thousand only) in favour of the DFO, Subarnapur Forest Division. 14. The list of articles put to tender represents a tentative requirement for various forestry management tasks and is subject to procurement based on need and the availability of funds. The purpose of the bid is to empanel a list of bidders to streamline the procurement process. Selection as a bidder for the article does not guarantee supply, as it depends on the allocation of funds to the Division during the financial year and may change according to the guidelines issued by the Government of Odisha from time to time.

PRINCIPLE OF FINALIZATION OF THE BID

1. Only bids fulfilling all eligibility criteria and complete documentation will be considered.
2. Technical specifications of the product must fully match or exceed the minimum required specifications.
3. Incomplete or conditional bids will be summarily rejected.
4. Among technically qualified bids, the lowest financial bid (L1) will be preferred only if the bidder has submitted valid experience in dealing with the Forest Department and has met all other specified criteria otherwise, the L1 bid shall not be considered for final selection.
5. Preference may be given to bidders with prior experience in supplying Thermal UAV Quadcopters to Government departments.
6. Warranty period and post-sale service arrangements will be evaluated.
7. Quality of the product, including brand reputation and customer support, will be considered.
8. Demonstration of the Thermal UAV Quadcopter, if required, must be arranged by the bidder at their own cost.
9. The decision of the Tender Committee regarding technical qualification and financial evaluation shall be final.
10. The Divisional Forest Officer, Subarnapur Forest Division reserves the right to cancel the entire tender process without assigning any reason.
