- 4. The bidder shall produce "Bid Security Declaration" towards Ernest Money Deposit / Bid Security as per Sl. 1 to 7 (Col.-5) of the table above as part of its Bid through a process as mentioned in the DTCN.

- 6. The bidders must possess compatible Digital Signature Certificate DSC of Class-III.
- 7. Bids shall be received only "Online" on or before 05.00 P.M of dated. 28.11.2024.
- 8. Bids received online shall be opened at 11.30 A.M on dated 29.11.2024 in the Office of the Divisional Forest Officer, Paralakhemundi in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 9. Engineering contractors who are desirous to avail the facility of exemption of EMD/ISD are required to submit the scan copy of affidavit along with bid document to the effect that he/she had not yet availed the facility during current financial year as per codal provision.
- 10. The SC/ST contractors willing to avail the facilities as fixed by Govt. will submit scan copy of the affidavit for the same along with tender documents; otherwise, they will not be entitled to avail such facilities.
- 11. Additional Performance Security shall be submitted by the successful bidder when the bid amount is less than the estimated cost put to tender as per DTCN Clause.

- 13. The Addendum/Corrigendum if any will be hosted in the website only.
- 14. The authority reserves all the rights to cancel any or all bids without assigning any reason.
