



BRAHMAPUR, DIST-GANJAM, ODISHA FOR THE YEAR 2025-26**

It has been decided to procure Tree Guard (Bamboo Gabion) of good quality by inviting through sealed tenders through offline in **Double Cover system**. The Reputed Registered Dealer/Manufacturer / Individuals expressing interest shall procure the tender Application Form from the website **odishaforest.in/ ganjam.nic.in**. The Cost of the Tender paper is **Rs. 10,000/- (Rupees Ten Thousand)** only which shall be deposited in shape of Demand Draft drawn in favour of the Divisional Forest Officer, Brahmapur Forest Division payable at Brahmapur.

The tenderer has to furnish all required documents & rate of the material, taxes separately in the tender form. **The tenderer has to submit the Technical bid and Financial bid in two separate closed cover**. The undersigned reserves the right to reject any or all tender without assigning any reasons thereof.

Eligibility: -

1. The invitation to participate in the Tender Document is open for Reputed Registered Dealer/ Manufacturer/ Individuals.
2. The Tenderer must not have been banned or black listed by any Government organization.
3. There must not be any adverse action pending against the Tenderer

TERMS & CONDITIONS

01. Offering of best price by firms/suppliers/supply house/manufacturers should be submitted in the Prescribed Form provided in the Tender documents.
02. Sample of the Product should be deposited in the Divisional Forest Office, Berhampur Division with proper acknowledgement. The sample should be in measurement of size 6' x 4' to be supplied.
03. The selected tenderer should supply the planting materials in good condition within 15 days from the date of placing order.
04. Delivery of the materials should be made in Range headquarters of this Division.
05. Damaged and sub-standard gabions should be replaced by the tenderer at their own cost.
06. All materials should be supplied as per the sample given and selection thereof, failing which the supply orders will be cancelled automatically and the bidders shall have no financial claim over the material supplied and need to lift all the materials from the site at their own cost.
07. The rate of materials should be quoted inclusive all taxes and transportation to the site.
08. Copy of GST clearance and Income Tax of last financial years should be accompanied along with the tender documents.
09. Payment will be made through MGNREGS Soft after receipt of all the materials ordered with checking of quality and quantity of the materials. The payment under MGNREGS Soft is subject to the availability of funds and the undersigned will not be responsible for any delay in payment due to non-availability of funds.
10. The tenderer should clearly mention the Bank A/c Number, Bank Address and IFSC Code in which the payment will be made.
11. The Tender Documents incomplete in any aspect is liable for rejection.
12. The Tenders received after the scheduled date and time is also liable for rejection.
13. The rate of successful bidder may be valid till next tender.
14. The undersigned reserve the right to reject/cancel any or all the tenders without assigning any reasons thereof and terminate the order in case of changes in the Government procedure of policy of instruction / direction and other exigencies.
15. The Tender will be finalized by the Tender Committee of the Division taking into consideration the price quoted and quality of the Product. Mere quoting lowest price for the product does not entitle a bidder for selection compromising the quality as decided by the Tender committee.
16. The decision of the Tender committee will be final and binding in any stage of the Tender Process.

17. Bid documents consisting of Specifications, the schedule of Quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website: odishaforest.in/ganjam.nic.in
18. The bidder shall have to deposit the cost of tender paper @ **Rs. 10,000/-** for participation in the bid in shape of Demand Draft only **in favour of Divisional Forest Officer, Berhampur Forest Division**. The Tender cost is non-refundable in nature.
19. The Successful Bidder(s) shall have to deposit Security Amount @ 5% of the total amount of tender in shape of TDR in favour of **the Divisional Forest Officer, Berhampur Forest Division** after finalization of the tender. The amount of Security Deposit is refundable after successful supply of the materials as per the standard of the Tender. Any discrepancies on the process will tantamount to the forfeiture of the Security Amount.
20. The Bid documents will be available in the website www.odishaforest.in/Ganjam.nic.in
21. Bids shall be received "**OFF LINE**" on or before **5.00 PM of dt 13.06.2025**
22. Bids received shall be opened at **02.00 PM on 16.06.2025** in the Office of undersigned in the presence of the bidders who wish to attend or represented by their authorized representative. Bidders who participate in the bid can witness the opening of bids. If the office happens to be closed for any administrative reason on the last date of opening of the bids as specified the bids will be opened on the next working day at the same time and venue.
23. Bidders are to submit the **TECHNICAL BID (Form-A) and FINANCIAL BID (Form-B) in a two Separate Sealed Cover** for the article intend to supply Planting Materials and both the cover to be enveloped in one Cover and dropped in the Drop Box. Any unsealed cover is liable for rejection of Tender Document.
24. The Authority will not be held responsible for any other inconvenience during bidding process.
25. The Addendum/Corrigendum if any will be hosted in the District website only and bidders have to access the same from time to time during the bidding process.
26. The intending bidders are required to furnish their e-mail address and cell phone number to inform them any message relating to the tender.
27. Selection will be made on cost effective basis i.e. lowest price for the same brand.
28. The bidders have to deposit their sample of product to be supplied to the office of the undersigned for quality assurance which will be finalized by the committee after opening of financial bids.
29. The bidders / vendors / supplier will have to attend the office of the undersigned on the date intimated later on for checking of quality assurance by the committee.

30. In case any bidder / vendor / supplier is not able to get tender documents online in the District Web Site due to any sort of unforeseen technical fault he/she may obtain the same from Head Clerk of the office of Berhampur Forest Division on payment of Rs. **10,000/- (Ten Thousand)** only of submission of Bank Draft of any Nationalised Bank/Scheduled Bank and submit the same in the Drop Box.
31. The quantity of article will be specified after finalization of the tender depending upon the availability of funds. The purpose of the bid is to empanel a list of bidders for Planting materials for the current financial year 2025-2026 to streamline the procurement within the restriction of timeline. The selection of a bidder is subject to change as per the time-to-time guidelines of the Government of Odisha.
32. Once opened, no tenderer will be allowed to withdraw from the tender process till its finalization.
33. Conditional tenders are not accepted and liable for rejection.
34. The rate so quoted will be firm and remain the same during the contract period of one year. No increase in price of any item shall be allowed under any circumstances during the period of contract.
35. Any sub-standard supply will not be accepted and the contract will be liable for termination with forfeiture of Security Deposit for breach of contract at any time without notice.
36. The vendor will be personally held responsible for the quality and quantity of the planting material supplied to the Division.
37. On receipt the supplies will be checked at the Range Point and any defects noticed will be treated as non-supply and will be dealt as per the terms and conditions of the tender.
38. The contractor will be responsible to obtain a receipt after checking of supplies from the official deputed to receive the supplies which will be attached with the bills to be submitted.
39. The supplies/items/articles at any point of time may be inspected by the Forest Officers or his authorized representatives or any officials in presence of concerned store in-charge and they will have the right to reject the supply in case of short supply or if the standard does not meet the specification as per the sample deposited. In case of defective / substandard supplies or in case of non-supply/short supply/delayed supply, the purchase shall be effected by the divisional Forest Officer, Berhampur or his representative from the open market. Any amount so incurred for the said purchase including carriage, transportation etc will be recovered from the contractor or his security till the new contract is finalized.

41. The Purchase Committee reserves the right to accept or reject the lowest bid without assigning any reason for such acceptance / rejection.
42. The undersigned reserve the right to increase or decrease the volume of any item or to the extent of 25 % of financial value or withdraw any items of supply at his discretion at any state of execution of works. The undersigned may extend the supply order at the same price for 6 month.
43. The rejected Planting Materials, if any must be removed within a week of the written or verbal notice.
44. Canvassing in any form whether direct or implied will led to disqualification.
45. Applicable taxes (TDS) as per prevailing rate and rules would be deducted from the bill amount of the suppliers.
46. The authority reserves the right to place order of supply, fully or partly to one or more bidders in respect of Planting Materials where ordered rate is same.
47. In case of any epidemic/pandemic/disaster/any other difficult situation due to which the cost of materials is escalated in the market or any other source, it shall be borne by the bidder. The contractor will ensure the supply of the item as per the terms and conditions of the tender. The contractor will have no claim or any compensation for any loss due to any disaster or inflation or cost escalation during the contract period.
48. All legal dispute shall have the jurisdiction to the District of Ganjam only.
