

The Tenderers or their authorized representatives are at liberty to remain present at the time of opening of the Tender. Tender papers found incomplete & received late shall be summarily rejected.


7. • The tender should be submitted in two bid system i.e., "Technical Bid" and "Financial Bid". The technical bid should contain all the information's relating to his eligibility along with cost of tender paper in appropriate shape. The technical bid and financial bid required to be submitted in two separate envelopes clearly mentioning on top of the envelope "Technical Bid" and "Financial Bid" respectively and both of these should be placed in a big envelope marked with The sealed offer must be superscribed in bold letters with **"Fabrication, Supply, Erection and Colorings of Tree Top Walk under Hirakud Wildlife Division, Sambalpur"**.
8. Price of Fabrication, Supply, Erection and Colouring of Tree Top Walk should be quoted inclusive of cost of transportation, installation, accessories and coloring materials and all the taxes.
9. Bidders should submit the technical bid with sketch of the Tree Top Walk mentioning dimension.
10. The Fabrication, Supply, Erection and Colouring of Tree Top Walk should be completed on or before 25th March'2026 positively.
11. The eligibility criteria and all other terms and conditions will be available in Divisional Notice Board as well as in Tender paper with effect from 10.00 AM of 02.02.2026 to 5.30 PM of 26.02.2026.
12. Bidders who will not meet the eligibility criteria mentioned in tender document will not be considered for further evaluation and their bids will be out rightly rejected.
