



1. General Instructions (Necessary support documents are to be enclosed)

- A. The tender process will be of two bid system-Technical Bid and Financial bid process. The tenderer should submit two separate sealed covers mentioning Technical Bid & Financial Bid. The tenderer which qualifies in Technical Bid only will be eligible to participate in Financial Bid.
- B. The Bid must Contain the Requisite Tender Document Cost of Rs.1000/- and EMD of Rs. 20,000/- as per the advised mode in the technical tender document. The Bid documents can be obtained from the office of the undersigned on payment of requisite fee or can be downloaded from website **www.balasore.odisha.gov.in and www.odishaforest.in from 11:00 AM of 14.02.2025 for bidding.**
- C. EMD should be in the shape of Demand Draft issued by a nationalized or scheduled bank in favour of "The Divisional Forest Officer, Balasore Wildlife Division, Balasore" Payable at Balasore. The bid document is available on working day in the office of the undersigned.
- D. The bidder must have valid GSTIN and must furnish the GST Registration certificate, GST Clearance certificate, PAN, IT and GST return for 2021-22 to 2023-24 in the bid documents.
- E. Last date of bid submission (by messenger / Courier / Post)- **25.02.2025 05:00PM** in the office of the Divisional Forest Office, Balasore Wildlife Division, Balasore.
- F. Date of bid opening – **27.02.2025 at 11.30 AM** in the office of the Divisional Forest Officer, Balasore Wildlife Division, Balasore.
- G. Tenderers have to mention the Company, Model, Manufacture year and detailed Technical Specifications of the Procurement of one (01) G2 X-Caliber Tranquilizer with accessories (PNEUDART, USA) in the Technical Bid. The Tender Evaluation Committee will scrutinize and verify the model & Specifications on the same date and will open the Financial Bids of technically qualified bidders.
- H. The decision of the Tender Evaluation Committee shall be final. The committee has right to alter/modify/add/delete any terms and conditions of the tender call notice. The committee also reserves the right to cancel the Tender process at any point of time without mentioning the reasons thereof.
- I. The Cost of tender paper of Rs. 1000/- and EMD cost of Rs.20,000/- in the shape of Demand Draft issued by a nationalized or scheduled commercial bank should be enclosed in technical bid only and not in financial bid.




1. Copies of GST returns (**FY 2024-25 till latest month**), Income Tax return (**Last three Financial Years**) along with copies of PAN and Valid GST registration Certificate shall be submitted along with the technical BID.
2. **EMD:** The value of Earnest Money to be deposited by the bidder shall be Rs.20,000/-. EMD should be in the form of Demand Draft / electronically from any Nationalized Bank in favour of Divisional Forest Officer, Balasore Wildlife Division, Balasoreat Balasore and must be accompanied with the technical bid. For unsuccessful tenderer EMD shall be refunded immediately after Finalization of the bid. EMD shall be forfeited if the L1 bidder fails to accept the order within 5 days from the date of issue of contract order.
3. **Experience Criteria:** The Bidder should have supplied Tranquilizer Gun/ Pistol to any Govt. Department of Odisha Government / Central Government for 2 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support. (Copy of Purchase Order / Supply Order / GeM Contract shall be submitted by the bidder for technical qualification). Tampering of Purchase Order / Supply Order / GeM Contract by the sellers shall be rejected outrightly without assigning any reason thereof). Legible copy of the Purchase Order / Supply Order / GeM Contract shall be submitted for technical qualification, if not the sellers shall be rejected outrightly without assigning any reason thereof.
4. **Security Deposit / BG:**
 - a) The supplier shall be responsible for any rectification of problems within the warranty period of 02 (Two) years. Replacement of any parts within the warranty period shall be on the part of the supplier.
 - b) Before award of contract on declaration of L1 bidder, the supplier shall deposit 3% of the contract value in form of Demand Draft /FD pledged in favour of Divisional Forest Officer, Balasore Wildlife Division, Balasore for security deposit within 05days of declaration of L1, otherwise contract shall not be awarded. After receipt of the security deposit only, contract order shall be awarded. The security deposit shall only be returned to the supplier on demand after 24 months without interest after following all conditions mentioned above.
5. **Delivery: 90 days from issue of Contract Order. Non-delivery within the date as in the contract order shall attract penal charges as per Govt. Guidelines.**
6. Undertaking that all the certificates / permissions / documents are valid and current as on date and have not been withdrawn / cancelled by the issuing authority. The Authority have right to ask for original documents if any doubt arises.
7. The bidders are requested to submit the details about their product in their letter head, duly signed during submission of technical bid. Basing on their product specification, and other requirement as pre the terms and conditions in the BID technical evaluation shall be made, thereafter acceptance of technical BID, online through GeM, in the following format:

8. Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.
9. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.
10. Warranty period of the supplied products shall be 02 years minimum from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods at consignee location. The seller should guarantee the rectification/replacement of goods in case of any break down during the warranty period.
11. The successful bidder has to supply all essential accessories required for the successful installation

and commissioning of the goods supplied. Besides standard accessories as per normal industry practice, following accessories must be part of supply and cost should be included in bid price.

- 12. Scope of supply includes Transportation, Installation (Installation shall be done at the Office of the Divisional Forest Officer, Balasore Wildlife Division, Balasore, Odisha), Commissioning and GST Charges to be included in the bid. The L1 bidder shall submit the equipment and the accessories to the Divisional Forest Officer, Balasore Wildlife Division, Balasore, Odisha physically by hand only or sealed pack. Tampering of packed in any form, the material shall not be accepted. No other modes shall be accepted for receiving the items. Only after successful operation of the item's payment shall be made. Field testing (both day and night) shall be done in presence of the supplier; if the equipment is found functioning in all aspect, then only the product shall be accepted else it would be rejected without assigning any reason thereof.**
13. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if: i) The Seller fails to comply with any material term of the Contract. ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent. iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly. iv) The Seller becomes bankrupt or goes into liquidation. v) The Seller makes a general assignment for the benefit of creditors. vi) A receiver is appointed for any substantial property owned by the Seller. vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
14. Non-compliance of any of the Terms & Conditions mentioned in the Bid, the bidder / seller shall be rejected.
