

- Mode of submission of Quotation is Speed Post/ Registered Post/ Courier / directly put in the Tender box of the Division Office only to the address as specified below during the office hour only. Submission of tender paper through any other mode and late tender will be rejected.

- The Tender papers shall be opened on Dt.09.02.2026 at 11.30 AM for Technical Evaluation under Chairmanship of Divisional Forest Officer, Hirakud Wildlife Division, Sambalpur and Financial Evaluation by HoD Level Purchase Committee. The Tenderers or their authorized representatives are at liberty to remain present at the time of opening of the Tender. Tender papers found incomplete & received late shall be summarily rejected.

- The tender should be submitted in two bid system i.e., "Technical Bid" and "Financial Bid". The technical bid should contain all the information's relating to his eligibility along with cost of tender paper in appropriate shape. The technical bid and financial bid required to be submitted in two separate envelopes clearly mentioning on top of the envelope "Technical Bid" and "Financial Bid" respectively and both of these should be placed in a big envelope marked with The sealed offer must be superscribed in bold letters with "**Supply, Installation and commissioning of 01(one) number of 20 (Twenty) Seater FRP Catamaran Boat**".
- 8. Price of 20 (Twenty) Seater FRP Catamaran Boat should be quoted inclusive of cost of transportation, installation, accessories and anchoring materials and all the taxes.
- 9. Bidders should submit the technical bid with sketch of the 20 (Twenty) Seater FRP Catamaran Boat mentioning dimension.
- 11. The eligibility criteria and all other terms and conditions will be available in Divisional Notice Board as well as in Tender paper with effect from 10.00 AM of 17.01.2026 to 5.30 PM of 07.02.2026.
- 12. Bidders who will not meet the eligibility criteria mentioned in tender document will not be considered for further evaluation and their bids will be out rightly rejected.
- 13. The Decision of the Selection Committee about determining the selection of the bidder shall be final. The DFO, Hirakud Wildlife Division, Sambalpur is not bound to assign any reasons therefore and reserve the right to reject any or all offer.
