- A. The tender process will be of two bid system-Technical Bid and Financial bid process. The tenderer should submit two separate sealed covers mentioning Technical Bid & Financial Bid. The tenderer which qualifies in Technical Bid only will be eligible to participate in Financial Bid.
- B. The Bid Must Contain the Requisite Tender Document Cost of Rs.1000/- and EMD of Rs.20,000/- as per the advised mode in the technical bid document only. Department of Odisha Government for 2 years before the bid opening date along with order value for minimum 60% of the Quantity in a Single Order through competitive bidding i.e. Reverse Auction mode. Tampering of Purchase Order / Supply Order / GeM Contract by the sellers shall be rejected outrightly without assigning any reason thereof). - 3. Bidder must have minimum average turnover of Rs. 15 Lakhs annually for last 04 years.
- 4. The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25% of the bid quantity at the time placement of Order. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during continuity of the contracted rates. Bidders are bound to accept the orders accordingly.
- 5. Scope of supply includes Transportation, Installation, Commissioning in the 100 km periphery from the divisional headquarters and GST Charges to be included in the bid.
