The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government, Odisha has to register under the state PWD in appropriate class of eligibility before award of the work.

- 6. The Bidders must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.
- 7. Bids shall be received only on "On-line" on or before 17:00 Hours of 15/12/2025.
- 8. Bids received "on-line" shall be opened at 13:00 Hours on 16/12/2025 n the office of the Divisional Forest Officer, Puri (WL)Division, Puri, in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging in to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- 09. Bids are to be submitted only the original BoQ uploaded by Publisher after entering the relevant fields without any alteration / deletion / modification Multiple BoQ submission shall lead to cancellation of bid.
- 10. As it is a percentage rate tender, the bidder quoting zero value is valid and will be taken as per the schedule of rates.

- 11. The Authority will not be held responsible for any technical snag or network failure during on-line bidding.
- 12. All Other details can be seen in the bid documents.
- 13. The addendum / Corrigendum if any will be hosted in the website only.
- 14. The intending bidders are required to furnish their e-mail address and cell phone number to inform them any message relating to the tender.
- 15. Engineering contractors who are desirous to avail the facility of exemption of EMD/ISD are required to submit the scan copy of affidavit along with bid document to the effect that he/she had not yet availed the facility during current financial year as per codal provisions.
- 16. Additional performance security shall be submitted by the successful bidder when the bid amount is less than the estimated cost put to tender as per DTCN clause.
- 17. If the rate quoted by the SC & ST category come to 14.99% (decimals up to two numbers will taken for all practical purpose) less than the estimated cost after availing 10% price preference as per Para-2 works Department Resolution No.27748 dt.11.10.1977, than the tender shall be finalized by the tender accepting authority through a transport lottery system along with other category of contractors whose rate are 14.99% less than the estimated cost in presence of all bidders/ their authorized representatives.
- 18. The bidders shall have to furnish "No Relation" certificate in shape of affidavit along with the bid documents to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.
- 19. Clear scanned copies of tender, PAN, Valid and active GSTIN certificate, no relation certificate in shape of affidavit, original valid contractor registration certificate with online registration in CDMS portal. Bid Security Declaration form, affidavit regarding genuineness and authenticity of documents, affidavit to avail price preference in case of SC & ST contractors should be uploaded along with the Bid document.
