## Competent i) Checks and Tests in Manufacturer's Plant / Fabricator's workshop by Authority of the Supplier.

a) During manufacture and especially prior to shipment/ dispatch, verification and checks shall be carried out in order to ensure that the supply is according to the specifications and approved design documents by the supplier.

b) The checks and tests to be carried out in the Supplier's premises shall include:

- functional check of all equipment.
- check of a vital dimension as per designs.
- check on assemblies, welds, screws, etc.

- 42. COMPLETION TIME: 15 days from generation of Contract Order. Noncompletion within the date as in the contract shall attract penal charges as per GeM Guidelines.
- 43.
