- Bids received "on-line" shall be opened at 11:30 Hours on dt. 27.12.2024 in the office of the Divisional Forest Officer, Sambalpur Forest Division, Odisha in the presence of bidders who wish to attend. Bidders who 6) participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- The items covered in Clause No-122 of DTCN for roads and building works are required as essential criteria for eligibility for qualification, Checklist should be duly filled in.
