The proof of registration from the appropriate authority shall be enclosed along with the Bid. The successful bidder who has not registered under state Government has to register under the state PWD in appropriate class of eligibility before signing of the agreement.

(ii) Only the successful Bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish as per Office Memorandum- 4559/W dt. 05.04.2021 of Works Department as Additional Performance Security in shape of Term Deposit Receipt pledged in favour of the Divisional Forest Officer, Sambalpur Kenduleaves Division, Sambalpur / Bank Guarantee in favour of the Divisional Forest Officer, Sambalpur Kenduleaves Division from any nationalised schedule bank in India counter guaranteed by its local branch within seven days, otherwise the bid shall be cancelled and further proceeding for blacklisting shall be initiated against bidder.
- 5. The Bid documents will be available in the website www.tendersodisha.gov.in from 10.00 Hour of 15.12.2025 to 17.00 Hour of 30.12.2025.
- 6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.
- 7. Bids shall be received only "Online" on or before 17.00 Hours of 30.12.2025.
- 8. Bids received online shall be opened at **11.30 Hours on 31.12.2025** in the office of the Divisional Forest Officer, Sambalpur Kenduleaves Division, Sambalpur, Odisha in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 9. The bidder shall transfer online the cost of bid document as shown in **column No. 5** above against each work through a process as mentioned under DTCN.
- 10. Other details can be seen in the bid documents.
- 11. The authority reserves right to cancel any or all bids without assigning any reason thereof.
- 12. The Addendum/ Corrigendum if any will be hosted in the website only.
- 13. If any of the intending bidders wish to withdraw from participation in the bid, he / she can freely withdraw from the participation before scheduled data and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him / her.
