The Divisional Forest Officer, Athgarh Forest Division on behalf of Governor of Odisha invites “On-line” percentage rate bids in **Single Cover/ Double-Cover** system for the following works from the appropriate Class of contractors as detailed in the table below registered with the state governments and Contractors of Equivalent Grade/ Class Registered with Central Government/ MES/ Railways for execution of the works. The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under the state government has to register under the state PWD in appropriate class of eligibility before signing the agreement.

1. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the **Government website-- <http://tendersorissa.gov.in>**
2. Bid must be accompanied with 1% EMD of amount put to tender and it should be submitted through on-line mode specified in tendersodisha.gov.in. No off-line receipt of tender paper cost will be allowed in e-procurement portal of Government of Odisha.
3. The Bid documents will be available in the **Government website- <http://tendersorissa.gov.in>** from **18.12.2025 to 05.00 PM of dt.26.12.2025 for online bidding.**
4. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
5. Bids shall be received only “on line” on or before **05.00 PM of dt.26.12.2025.**
6. Bids received on line shall be opened at **11.00 Hours on dt.29.12.2025** in the office of the **Divisional Forest Officer, Athgarh Forest Division** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time & venue.
7. As the tender has been called for online mode, the original documents like affidavit, authentication of license, Machinery affidavit shall be shown by the bidder at the time of verification and tender drop in office box need not be applicable.
8. Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
9. Any tenderer desirous to avail any facility as per certain circular/order of Government have to apply for the same in writing along with tender paper. Claim at the time of opening of tender or later will not be entertained.
10. This notice is to be read with all the Clauses / addendum to the “Procedure to participate in on-line bidding”.
11. If any of the tendering bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant Codal practice will be taken against him/her.

12. Any Corrigendum/ Addendum will be displayed in the website www.odisha.gov.in & <https://tendersodisha.gov.in> only.
13. The successful bidders will have to submit the additional Performance Security amount as in shape of T.D.R. pledged in favour of the **Divisional Forest Officer, Athgarh Forest Division**, payable at Athgarh in original before acceptance of tender, if their quoted amount is less than the estimated cost.
14. If after opening of the tender it is seen that, the tender has to be decided through a transparent lottery system then the lottery date will be intimated through email, Whats App no., By Phone Call and Speed Post. The lottery will be held even if no bidder remains present.
15. Bidder should have owned / hired / leased plant & machineries for the work as per requirement stated in DTCN.
16. Bidders should have experience in similar nature of work (As stated in DTCN).
17. Other details can be seen in the bidding documents.
18. The authority will not be held responsible for any technical problem / failure of Network, Server during schedule dates of online bidding.
19. The authority reserves right to cancel the bid without assigning any reason thereof.
20. Bidders shall provide their e-mail id, correspondence address, Mobile No. (WhatsApp) along with scan copy of valid GSTIN, PAN, Experience Certificate, Machinery documents and other documents as per DTCN clause.
21. The facilities for ST/SC contractors will be provided as per government order issued for time to time.
22. 1%(one percent) of the gross bill of contractor will be deducted towards labour Cess over and above the usual deductions.
23. The concessions/ facilities for 10% Purchase Preference shall be allowed only to the individual registered contractors belonging to Scheduled Caste and Scheduled Tribe having Registration Certificate up to "B" Class.
24. The bidder are required to upload self-signing scanned copy of information in Schedule- 'E' and required affidavit in Schedule- 'F' failing which the BID will summarily rejected.
25. The authority reserves the right to cancel any or all tenders without assigning any reason thereof.
