

- B. The Bid Must Contain the Requisite Tender Document Cost of Rs.1000/- and EMD of Rs. 50,000/- as per the advised mode in the technical tender document. Additional mandatory Terms and Conditions for qualifying in the Technical BID.

1. Copies of GST return (2021-22, 2022-23, 2023-24 till last month), Income Tax return (2021-22, 2022-23, 2023-24) along with copies of PAN card and GST registration shall be submitted along with the technical BID.
2. **Experience Criteria:** The Bidder must have regularly supplied Walkie-Talkie sets and vehicle mounted VHF sets to any Department of Odisha Government for 2 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support. (Copy of Purchase Order / Supply Order / GeM Contract shall be submitted by the bidder for technical qualification). Tampered copy of Purchase Order / Supply Order / GeM Contract shall be rejected and such bidder shall be liable for blacklisting and criminal action.
3. The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25% of the bid quantity at the time placement of order. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during continuity of the contracted rates. Bidders are bound to accept the orders accordingly.
4. Undertaking that all the certificates / permissions / documents are valid and current as on date and have not been withdrawn / cancelled by the issuing authority. The Authority have right to ask for Original documents if any doubt arises.
5. OEM or Authorized Seller of OEM shall be allowed to participate in the BID. The certificate to this effect should be submitted.
6. Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
7. Scope of supply (Bid price to include all cost components): Supply Installation Testing Commissioning of Goods. Pairing of Frequency shall be done by the seller as per the Govt. of Odisha, Forest Department before delivery.
8. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.
9. Warranty period of the supplied products shall be 02 years from the date of final acceptance of goods. The seller should guarantee the rectification of goods in case of any problem down during the warranty period.
10. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if: i) The Seller fails to comply with any material term of the Contract. ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent. iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly. iv) The Seller becomes bankrupt or goes into liquidation. v) The Seller makes a general assignment for the benefit of creditors. vi) A receiver is appointed for any substantial property owned by the

Seller. vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
