Solar Street Light Integrated with Early warning System and pole on behalf of Keonjhar Forest Division for use in different Range Offices of this Division. The expenditure is to be met from the approved budget under SSS-3128-Wildlife Protection and Conservation fund and SSWLCP under CAMPA APO 2025-26.

# GENERAL TERMS AND CONDITIONS AND INSTRUCTIONS TO BIDDERS

1. The bid document can be downloaded from the website <a href="www.odishaforest.in/https://kendujhar.odisha.gov.in/https://dfokeonjhar.com/">www.odishaforest.in/https://dfokeonjhar.com/</a> or can be obtained from Office of the Divisional Forest Officer, Keonjhar Division in working hours before the last date of receipt of bids. Bidders are advised to visit Annexure -1 of the terms and conditions (Technical specification of product) before participating in Tender.

#### 2. Tender process:

The Bid shall be submitted in two bid system as specified below:

- A) Cover -1 (Technical bid) should contain the following:
  - Copies of GST return (last filed), Income Tax return (last three years) along with copies of PAN and GST registration shall be submitted along with the technical BID.
  - Proof of supply order of Solar light during the last two financial year (Copy of Purchase Order / Supply Order / GeM Contract shall be submitted by the bidder for technical qualification).
  - Bidder must submit a notarized latest affidavit in Non-Judicial Stamp Paper with appropriate value of Rs. 100/- after the date of publication of this BID which is to be submitted by the Bidder that his /her firm has not been Blacklisted by any Civic Body failing which it will be summarily Rejected.
  - Bidder must have minimum average turnover of Rs. 50 lakhs. Annual for last 3 years.
  - Bidder must submit Turn Over Certificate from CA for the last three Financial Years.
  - All documents must be Self-Attested with proper stamp and Authorized Signatory failing which, it will be summarily rejected.
  - Noncompliance of any of the Terms & Conditions mentioned in the Bid, the bidder / seller shall be rejected.
- An A/c Payee Non-Refundable Bank Draft of Rs. 6,000/- drawn in Favour of "The Divisional Forest Officer Keonjhar Division" on any scheduled bank, payable at Keonjhar towards the cost of Tender papers and Processing.

- EMD / Financial Guarantee of the Bidder in the form of an A/c Payee Bank Draft issued by a Public Sector Bank (but not from any private bank) of Rupees Thirty-five Thousand five hundred, (Rs.35,500/-) in favour of "The Divisional Forest Officer Keonjhar Division" Payable at Keonjhar. (This draft will be returned to all unsuccessful bidders without any interest and in the case of successful bidder; the amount will be refunded without any interest only after issuance of purchase/work order.
- B) Cover 2 (Financial Bid) should contain the following: Financial bid.
- 3. Technical bid and financial bid are to be placed in two separate sealed envelopes (clearly super scribing "Technical Bid for Supplying of Solar light integrated with EWS system" and "Financial Bid for Supplying of Solar light integrated with EWS system" respectively) which in turn are to be placed in one bigger (Wax/ Tape sealed only) cover super scribing on the cover as "Quotation for Supplying of Solar light integrated with EWS system, Keonjhar Division -2025-26".
- **4.** The bids of the firms whose Financial Bid is not in a separate sealed cover or the rates quoted by them find mention in the Technical Bid shall be rejected forthwith. The financial bids of only those bidders shall be opened whose Technical Bids are found to be eligible.
- 5. Bid shall be submitted with a forwarding letter on the letter head of the bidder/ agency duly signed and stamped by authorised signatory on each page to ensure the compliance of scope, services and general terms and condition of the tender under reference.
- 6. No overwriting, corrections and cutting is permitted.
- 7. The Bid validity should be 90 days from the specified date of closing.
- 8. The completely filled bid document, duly sealed should be addressed to "The Divisional Forest Officer, Keonjhar Division and should reach the Office on/ or before 16:00 Hrs of 22<sup>nd</sup> December, 2025 by registered post or Registered Couriers or by the bidder himself with valid I-Cards or through Authorised Person of the bidder with an authorisation Letter and valid I-Card. First the Technical bids will be opened at 16.30 Hrs on 22<sup>nd</sup> December, 2025 and only those financial bids which have Technically Qualified will be opened next.
- 9. No reasons for delay in delivery of bids in D.F.O. Keonjhar Division Office shall be entertained.
  - 10. DFO, Keonjhar Division Office shall not be responsible for postal or any other delays. Bids received in an envelope that is damaged/ torn or merely stapled will be summarily rejected.
  - 11. Bidders or their authorised representatives, duly authorised in writing on letter head of the company, will have to be present at the time of opening of the Bids. At the opening of the

- 10. DFO, Keonjhar Division Office shall not be responsible for postal or any other delays. Bids received in an envelope that is damaged/ torn or merely stapled will be summarily rejected.
- 11. Bidders or their authorised representatives, duly authorised in writing on letter head of the company, will have to be present at the time of opening of the Bids. At the opening of the Technical Bids, they will have to produce all the original Credentials, copy of which have been enclosed with the Technical Bids, such as *Work Orders, Related Work Completion Certificates, Goods Service Tax (GST) & Income Tax* Returns, etc for verification. Failure to produce the Originals *shall* lead to the disqualification of Technical Bid.
- 12. If the date of tender opening, by any chance happens to be a holiday, the tender will be opened on the next working day at the stipulated time.
- 13. Award Criteria: The work shall be awarded to the technically qualified bidder/ firm quoting the lowest amount in the **Financial Bid.** In case the lowest amount thus quoted is identical in case of more than one bidder, then the contract will be awarded to the bidder through lottery process.
- 14. Any form of canvassing shall lead to disqualification in bidding. The DFO, Keonjhar reserves the absolute right to hold the free Fair as bid and when necessary and deciding the venue and timings and to accept or reject any/all bids without any further notice or intimation to the bidders, without assigning any reasons.

#### 15- Bank Guarantee/Security Deposit

- a) The supplier shall be responsible for any rectification of problems within the warranty period of 5 (five) years to make the unit fully functional. Replacement of any parts within the warranty period shall be on the part of the supplier. Any breakage due to wild animals / theft shall not be included in the scope of warranty.
- b) The supplier shall attend / rectify the defect within 10 days and for any break down period for more than 10 calendar days, shall be added to the warranty period. Failure to attend / rectify the defect within 10 calendar days after notifying, purchaser will rectify the defect from any other agency and supplier has to pay for this and purchaser will forfeit the Bank Guarantee/Security Deposit.
- c) The supplier should provide the service report to the purchaser. After Award of contract to the successful bidder, the supplier shall deposit 3% of the contract value in form of demand draft / FD Pledge in favour of Divisional Forest Officer, Keonjhar Forest Division for Bank Guarantee/Security Deposit within 30 days of Award of contract. After receipt of the Security Deposit only payment shall be made to the supplier. The Security Deposit shall only be returned to the supplier on demand without interest after following all conditions mentioned above.

#### 16- Service and Maintenance during warranty period

The supplier will be responsible to provide service and maintenance during warranty period of 5 years as and when required at the place of respective instruments installed.

#### 17- Additional Terms and Conditions.

- The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25% of the bid quantity at the time placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during continuity of the contracted rates. Bidders are bound to accept the orders accordingly.
- Payment shall only be done after submission of completion certificate and verification by the purchaser.
- Scope of supply includes Transportation, Installation, Commissioning and GST Charges to be included in the bid. The detailed product specification is given in Annexure -1
- COMPLETION TIME: 30 days from generation of work Order. Non-completion within the date as in the contract shall attract penal charges as deem proper.
- All bidder willing to participate in the Technical Bid, shall have to supply their prototype sample (as per product specification given in Annexure-1) at the Divisional Forest Officer, Keonjhar Division for checking the efficacy of the system. Only those bidders who pass the field test shall be accepted for technical qualification. The product shall reach the office on or before the last day of the bid closing. Sample shall not be received after the due date whatsoever the reason may be.
- The bidder at their own arrangement shall take back the prototype sample along with the accessories after generation of contract. This office shall not take any responsibility for returning of the samples.
- The bidders are requested to submit the details about their product in their letter head, duly signed during submission of technical bid. Basing on their product specification, and other requirement as pre the terms and conditions in the BID technical evaluation shall be made.
- The Authority reserves the right to withdraw or relax any of the terms and conditions mentioned above so as to overcome any problem encountered at a larger stage at the sole discretion of the authority.
- 18. **Budgetary limit:** Rs.35.4 Lakh. (including GST 18%). obligations under the work order.

## 19. Forfeiture of EMD/ Security deposit etc.:

If the successful bidder / agency refuses/ fails to accept Work Order issued by DFO, Keonjhar or the work order assigned to the agency/ bidder are not done as per the scope of work/ schedule of requirement, EMD/ Security Deposit will be forfeited. The work will then be allotted to the L2 bidder and the financial loss sustained shall be recovered from the L1 bidder.

#### 20. Rejection of the bid:

(a) The bidder is expected to examine all instructions, formats, terms & conditions in the bid document. Failure to furnish complete information or false information/documents shall result in rejection of bid.

- (b) In respect of interpretation/ clarification of this bid document and in respect of any matter relating to this bid document, the decision of DFO, Keonjhar shall be final.
- (c) The bidder will have to furnish the requisite document as specified in the bid document, failing which the bid is liable to be rejected.
- (d) The bids without EMD will be summarily rejected.
- (e) The bids received after specified date & time shall not be considered.
- (f) The bids received through fax/ email or any other mode other than specified in the tender document shall not be considered.
- 21. Blacklisting: Company/ Firm blacklisted by Government/ PSU/ Corporate organisation are not eligible to participate in the bidding process. If at any stage of bidding process or during the currency of work order, such information comes to the knowledge of DFO, Keonjhar, it shall have right to reject the bid or cancel the work order, as the case may be without any compensation to the bidder.

#### 22. Arbitration:

All disputes or difference whatsoever arising between the parties out of or relating to the meaning and operation or effect of the work order or the breach thereof shall be settled by reference to the arbitration as per Indian Arbitration Act.
