Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of sale and receipt of the bids as specified, the bids will be opened on the next working day at the same time and venue.
5. The cost of bid documents as mentioned in the Tender Call Notice shall be deposited through online.
6. The bidder shall have to submit 1% of estimated cost as EMD through online.
7. Other details can be seen in the bidding documents.
8. The authority will not be held responsible for any technical or network failure during on-line bidding.
9. The authority reserves all the rights to reject any or all tenders without assigning any reasons thereof.
10. If after opening of the tender it is seen that the rate quoted by more than one bidder is found to be equal & lowest, then the tender has to be decided through transparent Lottery system and the date of lottery will be intimated through E-Mail or Message.
