

5. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
6. Bids shall be received only "online" on or before 5.00PM of dt. 29.11.2024.

Bids received online shall be opened at 11.00 AM on dt. 30.11.2024 in the office of the Divisional Forest Officer, Bhadrak (WL) Division, Chandbali in the presence of the bidders, who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
8. The cost of Bid Documents should be paid online thorough e-procurement portal for the amount as specified under column No. 5.
9. The successful bidder who has quoted less bid price / rate than the estimated cost put up to tender shall have to furnished **Additional Performance Security (APS)** in shape of **Fixed Deposit Receipt / Bank Guarantee / Terms Deposit Receipt** duly pledged in favour of Divisional Forest Officer, Bhadrak (WL) Division, Chandbali as per the rate mentioned in the table below within 7 days from date of intimation otherwise the bids shall be cancelled & security deposit shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder.
