







**Terms & Conditions:-**

1. The Tenderer has to attach EMD @1% of the total Financial Bid Amount quoted by them in shape of Demand Draft purchased from any Nationalize Bank in favour of Divisional Forest Officer, Rourkela Forest Division payable at any nationalized bank of Rourkela Branch along with the tender; otherwise their bid shall not be qualified for the tender. The EMD shall be refunded to unsuccessful bidders.
2. The successful tenderer shall furnish a security deposit @3% of the total bid amount duly pledged in favour of the Divisional Forest Officer, Rourkela Forest Division in shape of Demand draft only drawn on any nationalized bank payable at Rourkela. This Security deposit of the successful tenderer shall be retained at Rourkela Forest Division & shall be returned after completion of the delivery of the materials. If the tenderer fails to deliver the required quantity of the Fiber Hexa/Square Net in time as per agreement, then the security deposit shall be forfeited to Govt.
3. The tenderer shall submit a sample (Size- 1m x 1m) in sealed packet of his/her materials while dropping of tender paper in the office of the DFO, Rourkela either in person or post/courier etc.
4. The Technical bid only shall be opened on **21.08.2024**. The Tender Selection Committee may inspect the HDPE Hexa Net production site mentioned by the bidder for on the site evaluation and sample collection. The date of opening of Financial Bid shall be communicated through the Notice Board of Division Office.
5. The Tenderer shall execute an agreement with the Divisional Forest Officer, Rourkela Forest Division in line with the terms and conditions laid out in the tender document.
6. The Tenderer shall deliver the HDPE Hexa Net at the approved sites within the period as per agreement.
7. The material should be delivered on the site after sampling at Division Office and proper weighing **in presence of the Forest Range Officer In- charge of the Range & taking counter signature on Challan Copy.**
8. A Sample of the HDPE Hexa Net shall be sent to any authorized laboratory for analysis. The Laboratory analysis report should match the specification furnished by the Tenderer in the original tender application form and the sample collected by the Tender Selection Committee. Failing to comply the Laboratory approval, the tenderer shall be responsible for non-payment of material cost & the material shall not be accepted.
9. The cost of materials furnished in the bid document shall be inclusive of transportation Charges and all Taxes admissible.
10. All payments to the Tenderer including EMD and Security Deposit shall be adjusted after completion of delivery of approved quality HDPE Hexa Net.
11. All documents and Original tender paper with Form No. A and B should be signed by the Tenderer.
12. Tenderers supplying HDPE Hexa Net/Square Net having better quality materials will be preferred over inferior ones without considering the L1.

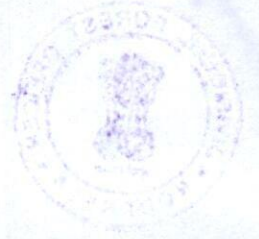
