4. Eligibility Criteria

1. The firm must have architects with the valid registration from Council of Architecture. The firm should have experience of carrying out similar works during the last seven (7) years. All necessary documents should be attached to validate the above criteria.
2. EMD exemption certificate in the attached format should be submitted.
3. The desirable annual turnover of the firm/bidder during each of the last 3 years should be at least Rs. 15 Lakh. However, this may not be treated as an essential criterion.
4. The firm should have done at least
 - (a) Three similar works whose built up area is not less than 50% of the total area proposed to be developed (i.e., 3 works of at least 4 Hectares) **OR**
 - (b) Two similar works whose built up area is not less than 80% of the total area proposed to be developed (i.e., 2 works of at least 6.4 Hectares)
5. The architect/firm should be well conversant with the building by-laws prevailing in Odisha.
6. The experience of the architect/firm should include all the services for the buildings such as architectural, structural, engineering and all internal and external services including electrical, AC, plumbing, sanitary, water supply, soil and storm water drainage, firefighting, interior, gymnasium, parking, rainwater harvesting, installing solar power generation etc.
7. Prequalification of the architects/fir, shall be subject to thorough verification of their credential submitted by them and inspection of works carried out/in progress by them by the DFO office.

If due to any exigency, the due date for opening of the bids is declared as a closed holiday, the bids will be opened on the next working day at the same time or any other day/time, as intimated by the Office.

The invitation to e-tender is subject to fulfillment of instructions and conditions as per schedules below. Bidder should carefully read all the terms & conditions before submitting their offers.

This Invitation of Proposals is being issued with no financial commitment and the DFO Angul reserves the right to change or vary any part thereof at any stage. DFO Angul also reserves the right to withdraw the tender, should it become necessary at any stage.

6. Mode of submission of Proposals

The Tender is to be submitted under “TWO BID” system.

On the day of Tender opening only technical bids (Techno-Commercial Bids) will be opened. Price/Financial bid will be opened on a fixed later date for the successful technical bidders. The date of opening of Price Bid will be intimated to the successful technical bidders only.

No query or complain from bidder will be entertained after completion of bid opening in regard to bid opening or content of other’s bid.

As, such Bidders are requested to see the website once again before due date of tender opening to ensure that they have not missed any corrigendum uploaded against the said tender after downloading the tender document. The responsibility of downloading the related Corrigendum, if any, will be that of the downloading parties. No separate intimation in respect of corrigendum will be sent to Bidders who down loaded the documents from website as information in this respect (names of parties) will not be available to website.

DFO Angul, reserves the right to accept or reject any tender or the whole tender process at any time without assigning any reason what soever.

7. Rejection of Bids:

Canvassing by the Bidder in any form, unsolicited letter and post- tender correction may invoke summarily rejection with forfeiture of Bid Security/EMD.

Conditional tender i.e., tender submitted incorporating bidder’s own imposed condition(s) will be summarily rejected.

8. Late Proposals

Proposals submitted after the due date and time will be summarily rejected.

9. Modification and withdrawal of Proposal

No bid may be withdrawn in the interval between the deadline for submission of bids and expiration of the period of bid validity specified. Withdrawal of a bid during this period will result in blacklisting of the Bidder’s as per rules.

10. Proposal Opening and evaluation of Bids

For the bids surviving the technical evaluation which have been found to be responsive the evaluation & comparison shall be made in accordance with the price quoted and comparison of rates will be made as per financial bid proforma given in the tender document (Annexure - Price Bid). The financial quote should only be submitted in sealed envelope in accordance with the BOQ; failing which their offer will be rejected.

Lowest bidder will be arrived on the basis of total final cost.

Sub-contracting of the job is not allowed.

The time limit for successful construction and development of Biodiversity Park shall be 9 months from the date of award of contract.

11. Payment Terms, Performance Security and Penalty–

Milestone payment schedule for various activities is as under:

Phase 1 -

1. 10% of the fees after receiving all the structural drawings starting from foundation to super structure of all the structures with location details (as and when necessary) as per the approved layout plan after vetting these from any structural firm.
2. 25% of the fees after receiving all the architectural drawings such as plan, front & back elevation, section, side elevation, staircase details etc. from foundation to superstructures with location details (as and where necessary) or any other additional drawings as required such as 2D drawings, 3-D views and 3-D walk through etc.
3. 25% of the fees after submission of the detailed estimate based on latest schedule of rates, Schedule/Bill of Quantities with detailed specifications, approved list of materials, detailed measurement sheet for each item of work, rate analysis for market rate items and approval of the estimate.
4. 40% of the fees after submission of tender documents and awarding of the work to PMC and contractor and commencement of work at site or differential amount as calculated from the actual cost of the work of all the contractors' bid. It will be paid on verification of contractors' bills based on progress of the works and measurement of the works certified by the PMC at site.

Phase 2 –

1. 40% of the fees after successful completion of about 50% of work (i.e., based on settlement of bill cumulatively valued at 50% of the tender cost) as awarded to the contractor.
2. 60% of the fees after successful completion of entire work (i.e., based on issue of completion certificate by the competent authorized person by DFO Angul) as awarded to the contractor.

Note: Calculation of the fees initially (Phase 1 – SN 1, 2 and 3) will be based on the preliminary estimated cost of the project. After finalization of the tender for award of actual works, the fees shall be worked out based in this value with adjustment of stage payment made till that date. However, overall fees payable will be limited to the fees in %age payable on actual cost of the work finalization of all the contractor's bill and after adjustment of stage-based payment made till that date.

GST will be paid extra as applicable. TDS as applicable on IT and GST will be deducted. Payment will be made through electronic mode only.

Performance Security: Unconditional Performance Security (Bank Guarantee/FDR) should be furnished for an amount of minimum 5% of the value (estimate fees as quoted in the EOI) within 7 days of the receipt of the Work Order which shall be valid till 60 days beyond the date of all contractual obligation of the bidders including warranty/Guarantee obligation. The Performance Security should be provided in the form of Bank Guarantee/FDR issued by a Nationalized/Scheduled bank pledged in favour of "Divisional Forest Officer, Angul".

Penalty: In the event of failure to supply architectural design within the stipulated delivery period, DFO Angul reserves the right to accept the delivery in part or in full and to claim liquidated damages from the firm @ 0.5% per week subject to the maximum of 5% which will be levied on the services which have been rendered late.

12. Termination of Contract

1. DFO Angul reserves the right to terminate the contract, in whole or in part for its (the DFO Angul's) convenience or frustration of Contract, by serving written 'Notice for Termination' on the successful bidder at any time during the currency of the contract. The notice shall specify that the termination is for the convenience of the Client or the frustration of the contract. The notice shall also indicate inter-alia, the extent to which the bidder's performance under the contract is terminated, and the date with effect from which such

termination shall become effective.

2. Such termination shall not prejudice or affect the rights and remedies accrued and/ or shall accrue after that to the Parties.
3. Unless otherwise instructed by the DFO Angul, the contractor shall continue to perform the contract to the extent not terminated.
4. All Defect/Liability/obligations, if any, shall continue to survive despite the termination.

13. Force Majeure

- a. However, the bidders shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- b. For purposes of this Clause, "Force Majeure" means an event beyond the control of the bidders and not involving the bidders' fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the DFO Angul either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- c. If a Force Majeure situation arises, the bidders shall promptly notify the DFO Angul in writing of such conditions and the cause thereof. Unless otherwise directed by the DFO Angul in writing, the bidders shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

14. Right to accept or reject

No commitment to accept lowest or any tender: DFO Angul shall be under no obligation to accept the lowest or any other quotation received in response to this tender enquiry and shall be entitled to reject any or all offers including those received late or incomplete offers without assigning any reason whatsoever.

Client's right to accept any offer and to reject any or all offers: DFO Angul reserves the right to accept or reject any tender or reject all tenders at any time prior to award of contract, without thereby incurring any liability towards the affected Bidder(s) or any obligation to inform the affected Bidder(s) on the grounds for the DFO Angul's action. Further, DFO Angul reserves the right to place order for full quantity or part thereof, as considered necessary

In the event any of the job quoted by the bidders in their tenders are covered under any services and liable for GST, in such cases specific indication about providing such taxable services and percentage/amount of GST chargeable thereon must be mentioned in the tender and such GST must be deposited in the Government treasury as per extant GST rules of Government of India and a proof of which shall be submitted by the Bidder to the DFO Angul.

Any statutory **Certificate/Permission/License** required for the contract has to be procured by the firm at their own cost.

15. Disputes and Jurisdiction

All disagreements, disputes, difference that may arise between the DFO Angul and the bidders which cannot be resolved through mutual negotiations shall be referred to an Arbitrator appointed in accordance with the provisions of relevant Indian or International Law as the case may be. The venue of the proceedings and arbitration shall be Angul, Odisha, India.

The Court in Angul, Odisha, India shall have the exclusive jurisdiction to try all or any of the disputes. All legal disputes are subject to the jurisdiction of Angul Courts only.

16. Liability

The liability of the selected applicant in any case shall not be beyond the amount payable to the selected agency.

17. Indemnity

The selected agency always during the pendency of this agreement, keep the Government/DFO office indemnified to an amount not exceeding the total fees payable to the selected agency under this agreement.

18. Confidentiality

The Selected Agency shall treat the details of the output of the Assignment and the services as confidential and for the Selected Agency's own information only and shall not publish or disclose the details of the output, deliverables/milestones submitted the Selected Agency or the services in any professional or technical journal or paper or elsewhere in any manner without the previous written consent of the DFO Angul.
