Sealed quotations in plain paper/letterheads are invited from the intending owners having seagoing SONA-type trawler with 400 HP with a valid license along with insurance cover for "Engagement on hire basis for Sea Turtle Protection duty during 2025-26 seasons." The period of engagement shall normally be from **December 2025 to March 2026**. The owners are to quote the monthly hire charges inclusive of all taxes, if any, but not the cost of fuel, which will be borne by this division. The detailed terms and conditions for the engagement of the trawler can be obtained from the Office of the undersigned during office hours from **25th November, 2025** onwards. The quotation for hiring of the trawler (400 HP) is to be submitted separately.

Sealed quotations are invited **from Dt.25/11/2025 at 10:00 AM to 05/12/2025, up to 3:00 PM**. The quotations will be **opened on 06/12/2025 at 1:00PM** in the conference hall of the undersigned. **TERMS AND CONDITIONS FOR ENGAGEMENT OF TRAWLER FOR
PROTECTION OF SEA TURTLE DURING 2025-26.**

- 1) The Trawler owner shall be paid _____ (Rupees _____) per month towards. (Rupees hire charges of the fully equipped and manned Trawler. No separate charges are payable to crew members and for repair/maintenance of his Trawler.
- 2) The Trawler bearing _____ shall be under the control of Divisional Forest Officer, Puri Wildlife Division and under the supervision of Range Officer, Astarang who shall deploy it and use it as per the requirement i.e. patrolling in the prohibited zone to prevent unauthorized fishing in the zone prohibited under the provisions of OMFRA.
- 3) The Engaged trawler shall be required to be kept in excellent working condition throughout the period of its agreement at all hours of the day and night. The period of engagement of the Trawler is from **December-2025 to March-2026**. The period may be extended depending upon the exigency.
- 4) The Trawler will be ordinary kept at the bank of Kadua River in front of Ganga Devi temple or at Nuagarh Jetty so that effective control can be exercised in the entire Devi Coastal waters. The **SONA Trawler of 400 HP** may come to Astarang harbor for water and other provisions as and when required or any area in high sea as per requirement of Forest Department intimated through DFO, Puri Wildlife Division.
- 5) The Trawler/boat must be in Sea Worthy Condition and must have valid Marine Registration certificate issued by the Fisheries Department and year of make of the **trawler must be within 03 (Three) years** as on date of the publication of the QCN. Original documents have to be submitted by the successful bidder.
- 6) The hired charges will be paid on monthly basis but does not include the cost of diesel to be used in the Trawler. Fuel in the shape of diesel at a maximum rate of **35 (Thirty-five) liters** per hour of use will be supplied by the department. The updated logbook of the trawler is to be maintained by the driver/boatman of the boat and duly countersigned by designated departmental staff. Log book will be the property of the Govt.
- 7) Engine oils and any other consumable required for the running of trawler shall be provided by the Owner at his own cost.
- 8) If for reason whatsoever the owner is unable to provide the Trawler for use then he shall make alternative arrangement by providing another trawler of the same type for the patrolling purpose.
- 9) Payment shall be made monthly in favour of the trawler owner on receipt of the bills through Range Officer, Astarang who will certify regarding period / time of engagement. **The monthly hire charges will be paid in every succeeding month depending upon availability of Fund. No. Advance payment will be done.**
- 10) The trawler shall report for duty for full month at any time as required by the hirer starting for the period from December 2025 to March 2026 after which the boat will be deemed to have been disengaged by the First party without any information.

- 11) A log book shall be maintained by the trawler captain which will bear the details of hour of use and the area of use. This log book shall be signed by the trawler captain and head of the enforcement staff whenever the trawler is taken for sortie. This will be the property of Govt.
- 12) **Department will not be responsible for any damage to the trawler or crew members during the operation.**
- 13) The Trawler owner shall take care of all legal formalities like registration, insurance cover for the trawler and its staff and the hirer will be in no way responsible for such requirement.
- 14) The hirer is at liberty to affix wireless set, antenna, GPS-PDA, Flags, Gun, mount, life jacket search light, loudspeaker or any other instrument of equipment's, necessary for the turtle protection work in the prohibited zone as per prohibited zone as per provisions of OMFRA
- 15) The hirer shall be at the liberty to discontinue hiring of the trawler during the current hirer period without assigning any reason thereof.
- 16) **The trawler must have registration certificate and boat license with valid plying certificate.**
- 17) The owner will be responsible for keeping the Trawler in sea-worthy conditions at all times for round the clock use. For the above all the operational costs including stores, spares, lubricants, wages of staffs, provident fund, victualling, fresh water, dry docking and repairs, survey etc. will be to the account of the contractor.
- 18) Owner/Contractors to provide: Except as otherwise stated in this tender or as may be agreed from time to time, he shall provide and/or pay for all requirements, cost or expenses relating to trawler. Their master and crew which, without prejudice to the generality shall include but not limiting to:
 - i. Dry docking, repairs and all expenses associated therewith.
 - ii. Provisions, wages and all other expenses of the Master, officers and crew including their insurance.
 - iii. Deck, Cabin and engine room stores.
 - iv. All necessary lubricants
 - v. Insurance policy covering various risks including Hull & machinery insurance of the vessels.
 - vi. All taxes duties and levies including but not limited to the taxes, duties and levies imposed on the income of the Tenderer, its employees or any levies etc. on any purchase made by the Tenderer, and/or any penalties imposed by any authorities from time to time.
 - vii. Necessary intrinsically safe cables, plugs, Junction Box, Circuit breakers etc. as the case may be for drawing shore power shall also be supplied by the contractor.
- 19) The Owner/Contractor shall carry out the works strictly in accordance with the contract to the satisfaction of DFO, Puri WL Division and shall comply with and adhere strictly to his instructions and directions on any matter in relation with the contract.
- 20) On the date of commencement of the service, the trawler shall have valid registration certificate and boat license with valid plying certificate which should be kept valid throughout the contract.
- 21) The safety & Security of the trawler and the crew will be the responsibility of the contractor.

22) **Substitute:** The tenderer is allowed to substitute the deployed Trawler by a sister/similar/better Trawler during the contract period provided the speed/type criterion as specified in the tender during the contract period provided the speed/type criterion as specified in the tender is met and fuel consumption is same or lower than as stated by the Contractor in the bid. The Contractor shall submit all the details of the substitute Trawler and obtain the approval of the DFO, Puri WL Division before deployment.

23) **Penalty:** If the trawler is inoperative /or unavailable, daily hire will not be paid. (No Work No Pay). Under any circumstances, if the originally offered/substitute Trawler is not made available beyond **30 Days**, then the contract may be terminated along with forfeiture of Performance Security deposit and debar the firm for a period of 02 years from Participating in the tenders.
