

4. The bid documents will be available in the website: www.tendersodisha.gov.in from 10 AM of dt. 18.12.2023 to 5.00 PM of dt. 27.12.2023 for online bidding.
5. The bidder must possess compatible **Digital Signature Certificate (DSC)** of Class-II or Class-III.
6. Bids shall be received only "online" on or before dt. 27.12.2023 up to 5.00 PM.

7. Bids received online shall be opened at **11.00 A.M. on dt. 28.12.2023** in the office of the Divisional Forest Officer, Angul Division, Angul in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
8. The cost of bid documents should be paid online through e-procurement portal for the amount as specified under column no.5.
9. The successful bidder who has quoted less bid price / rate than the estimated cost put to tender shall have to furnish additional performance security (APS) in the shape of Fixed Deposit Receipt / Bank Guarantee / Term Deposit Receipt duly pledged in favour of Divisional Forest Angul Division Angul as per the rate mentioned in the table below within 7 days from date of intimation otherwise the bid shall be cancelled & security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.
