The Divisional Forest Officer, Sambalpur Kenduleaves Division on behalf of Governor of Odisha invites Percentage Rate bids in **Single Cover System** in online mode for the works as detailed in the table, from the class of eligible contractors as mentioned in column-6 (Six) registered with the state Governments and contractors of equivalent Grade / Class registered with Central Government / MES / Railways for execution of Composite Building works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. The successful bidder who has not registered under state Government has to register under the state PWD in appropriate class of eligibility before signing of the agreement.



(i) The bidder shall furnish bid security as specified for the work in the table col.4 above as part of its bid through in shape of N.S.C./ Post Office Saving Bank Account / Post office Time Deposit Account / Kisan Vikas Patra / Bank Guarantee in favour of Divisional Forest Officer, Sambalpur Kenduleaves Division from any Nationalised Scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar / e-Bank Guarantee executed on the National e-Governance Service Limited (NeSL) Digital Document Execution Portal towards E.M.D./ initial Security Deposit / any other security deposit from the contractor or supplier as per Office Memorandum No- 07554600032022-1499/W Dt. 01.02.2023 of Govt. of Odisha, Works Department.


4. (ii) Only the successful Bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish as per Office Memorandum- 4559/W dt. 05.04.2021 of Works Department as Additional Performance Security in shape of Term Deposit Receipt pledged in favour of the Divisional Forest Officer, Sambalpur Kenduleaves Division, Sambalpur / Bank Guarantee in favour of the Divisional Forest Officer, Sambalpur Kenduleaves Division from any nationalised schedule bank in India counter guaranteed by its local branch within seven days, otherwise the bid shall be cancelled and further proceeding for blacklisting shall be initiated against bidder.
5. The Bid documents will be available in the website **www.tendersodisha.gov.in** from **10.00 AM of 01.01.2026 to 4.30 PM of 12.01.2026** & the Bid documents will be opened on **12.01.2026 at 5.00 PM.**
6. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
7. Bids shall be received only **"Online"** on or before **4.30 PM of 12.01.2026.**
8. Bids received online shall be opened at **5.00 PM of 12.01.2026** in the office of the Divisional Forest Officer, Sambalpur Kenduleaves Division, Sambalpur, Odisha in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
9. The bidder shall transfer online the cost of bid document as shown in **column No. 5** above against each work through a process as mentioned under DTCN.
10. Other details can be seen in the bid documents.
11. The authority reserves right to cancel any or all bids without assigning any reason thereof.
12. The Addendum/ Corrigendum if any will be hosted in the website only.
13. If any of the intending bidders wish to withdraw from participation in the bid, he / she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him / her.
14. Any tenderer desires to avail any facility as per certain circular / order of Govt. must apply for same along with tender paper. Claim at the time of opening of tender or later will not be entertained.
15. Authority will not be held responsible for any technical problem / failure of network, server during the schedule dates of online bidding.
16. The online bidder shall have to produce the original documents for verification in support of scanned copies and statements uploaded in the portal within three days from the date of opening of the bid.
17. Conditional tender will be summarily rejected. The Department reserves the right to reject any or all bids without assigning any reason thereof.
18. As per OPWD code Clause 12.4 Appendix-IX(A) the contractors participated in the above tender mandated to register themselves in Contractor Data Base Management System (CDMS) available at www.cdmsodisha.gov.in.
19. Engineering Contractors desirous of availing EMD exemption shall submit a scanned copy of an affidavit alongwith the bid document, declaring that they have not availed the facility during the current financial year as per codal provisions.
20. SC / ST Contractors willing to avail Government-approved facilities shall submit a scanned copy of the relevant affidavit alongwith the tender documents; otherwise they will not be entitled to such facilities.
21. Additional Performance Security shall be submitted if required, as per DTCN.
22. In case of equal lowest bids, lottery will be conducted and bidders will be informed.
23. As it is a percentage rate tender, the bidder quoting zero value is valid and will be taken as schedule rates.
24. Additional performance security shall be submitted by the successful bidder if the bid amount is lower than the estimated cost put to tender as per DTCN clause.






