1. **The Silviculturist, Silviculture Division, Rayagada** on behalf of Governor of Odisha invites **Percentage Rates bids in (Single Cover System in online mode system)** through e-**procurement** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned below registered with the State Government and Contractors of equivalent Grade/ Class Registered with other state Government/ Central Government/ MES/ CPWD/ Railways for execution of **Civil Works**. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government, Odisha has to register under the state PWD in appropriate class of eligibility before signing of the agreement.
2. The bidders may submit bids for the following works.

Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 1% of the amount put to tender as Bid security.

Note: Non submission of original documents like tender paper cost, EMD,RC,PAN,GSTN, No relation certificate, plants and equipments ,Affidavit in schedule-F & Schedule- E during the stipulated time period as mentioned above will be liable for rejection of tender while verification.

6. The bidder must possess compatible **Digital Signature Certificate (DSC)** of **Class-II or Class- III**.
7. Bids shall be received only “online” from **dated. 26.12.2024 to 05.01.2025 up to 5.00 PM of dated** except from those contractors who have failed to carryout construction works after finalization of their Tenders as L1 and L2 Bidders for a period of three years from the date of assignment of works to them as L1 and L2 Bidders and as such their Tender papers in this Division will not be entertained and will be automatically rejected.
8. Bids received online shall be opened at **11.00 A.M. on dated. 06.01.2025** in the office of the Silviculturist, Silviculture Division, Rayagada,At : Goutam Nagar 6th Lane, Raniguda Farm PO./Dist. Rayagada, Pin: 765001, Odisha in the presence of the bidders who wish to attend. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. **And the financial bids shall be open after the Evaluation of Technical Bids.**
9. The SC/ ST Contractors willing to avail the facilities as fixed by the Government will submit the scan copy of the Affidavit for the same along with tender document, otherwise they will not be entitled to avail such facilities.
10. Engineering contractors who are desirous to avail the facility of exemption of EMD/ISD are required to submit the scan copy of affidavit along with bid documents to the effect that he/she had not yet availed the facility during current financial year as per codal provision.
11. The authority reserves right to cancel any or all bids without assigning any reason thereof.

12. Subsequent corrigendum/addendum/cancellation if required shall only be available in website indicated above.
13. The successful bidder who has quoted less bid price/rate less than estimated cost put to tender as per works deppt. Govt of Odisha office memorandum No. 4559 dated. 05.04.2021 shall have to furnish i.e. as additional performance security (APS) in shape of Bank Guarantee (BG)/KVP/NSC pledged in favour of Divisional Forest Officer, Rayagada forest division of concerned division within 7 days intimation otherwise the bid shall be cancelled and security deposit shall be forfeited further, proceeding of blacklisting shall be intimated against the bidder.

14. Any tenderer desirous to avail any facility as per certain circular/ order of Government have to apply for the same in writing along with the tender paper. Claim at the time of opening of tender or later will not be entertained.
15. If any of the intending bidders wish to withdraw from participation in the bid, He/ She can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant Codal practice will be taken against him/her.
16. The authority will not be held responsible for any technical problem/ failure of Network, Server during the schedule dates of online bidding.
17. Contractor has to submit Contractor Database Management System (CDMS) registration failing which tender will summarily rejected as per E.I.S (Civil) Letter No. 30613 (12) dated. 22.07.2019.
18. The Agency has to submit Bid Declaration as per Finance Deptt. Letter No. 8943 dated. 18.03.2021 (Schedule-K).

21. The authority reserves all the rights to cancel any or all bids without assigning any reason.
22. The rate quoted by the contractor shall be excluding of GST, the GST amount shall be payable to contractor as mentioned in BOQ.
