- The tenderers have to submit the rates for the supply of medicines for the period of one year
  from reputed companies/multi-national companies/Distributor/Stockists for the use in
  MVU Sambalpur for the treatment of wild animals/domesticated animals/cattle (delivered
  at the Mobile Veterinary Unit of the Sambalpur Forest Division at the cost of contractor)
  with a highest discount on MRP. This rate should be quoted without any other conditions.
  Taxes etc shall be as per Govt rules in force.
- 2. The period for supply of medicines will be from 15.11.2024 to 31.3.2025. The highest offered discount for the medicines should be submitted in the sealed envelope in the prescribed proforma latest by 12.11.2024 at 05.00 PM
- 3. The tenderer has to submit an amount of Rs.30,000/- (Rupees Thirty Thousand) only as earnest money deposit in the form of demand draft in favour of Divisional Forest Officer, Sambalpur Forest Division from a Nationalized Bank/Scheduled Bank along with this tender failing which the tender will be rejected.
- 4. The successful tenderer has to submit a security deposit of Rs.50,000/- (Rupees Fifty Thousand) only in the Term deposit in the Nationalized Bank /Scheduled Bank I n favour of Divisional Forest Officer, Sambalpur Forest Division payable at Sambalpur. The security deposit would be released in favour of tenderer after the successful completion of the tender period. In case of any breach of terms and conditions or unsatisfactory performance or other lapses, the security deposit would be forfeited to Government. The decision of the Divisional Forest Officer, Sambalpur Forest Division would be final and binding on this matter.
- 5. The tenderer has to supply the medicine to the MVU as and when requisitioned for as per the direction of the Veterinary Officer, MVU Sambalpur. No transportation charges shall be given for the same. The supply may be for more than one or two time a day as per the need/emergent situation. The indented medicines should be supplied to the MVU latest by 3(Three) days positively.
- 6. The tenderer has to attach copy of annual Income Tax return of last Three years and good conduct certificate from the two Gazetted Officer of Government of Odisha as well as experience certificate, voters identify card, residence proof.
- 7. The Divisional Forest Officer, Sambalpur Forest Division may cancel the tender at any time without assigning any reason.

- 8. The Divisional Forest Officer, Sambalpur Forest Division at any time by notice in writing can terminate the contract without any compensation if the contractor commits any breach of the contract. Divisional Forest Officer, Sambalpur Forest Division reserves the right to impose monetary penalty at his discretion the extent of average monthly contract value on each occasion or actual loss occurred to Government whichever is higher.
- 9. The tenderer shall be personally responsible for retaining and safe custody of the medicines requisitioned from this office until the same are handed over to the MVU section. Any claim of lose/lost compensation etc shall be paid by him and the Sambalpur Forest Division will not be responsible to the above. The tenderer should have valid drug licence/ narcotic licence in his name from the Government authority for supply of medicines.
- Tenderer should have experience for supply of medicines to National Park, Wildlife Sanctuary, Tiger Reserve, Govt Veterinary Hospitals, Govt Hospitals, Aquarium or Museums etc.
- 11. All powers in awarding contract I n relaxation of any eligibility criteria lies with the Divisional Forest Officer, Sambalpur Forest Division.
- 12. The Divisional Forest Officer, Sambalpur Forest Division shall have all the right to reject/accept any tender without assigning any reason.

- 15. Any clause of the tender can be cancelled/modified/altered during the course of the tender /period of work at the discretion of the Divisional Forest Officer, Sambalpur Forest Division and the tenderer shall have to accept the altered or modified condition.

#### PENALTY

If the contractor commits any breach of this contract, he shall be liable to be fined up to an amount not exceeding 1/4 th of the monthly contract value for every act of default or negligence. On demand the amount should be deposited within 10 days. The Divisional Forest Officer, Sambalpur Forest Division reserves the right to cancel the contract within 15days notice period.

### PERIOD OF CONTRACT

- A. The contract will be for a period of one year from 15.11.2024 to 31.03.2025.
- B. Under no circumstances the contractor will be allowed to leave before completion of first year of the contract.
- C. In the event of contractor leaving before completion of one year, the security deposit will be forfeited.
- D. The validity period of present tender is one year, but it can be extended on the same approved rates to the discretion of Divisional Forest Officer, Sambalpur Forest Division on the satisfactory performance of the contractor.

#### START OF THE OPERATION

- The successfully tenderer shall have to start supply of medicines as per requisition of Veterinary Officer of MVU Sambalpur vetted by ACF Enforcement/ DFO Sambalpur from 15<sup>th</sup> November 2024 positively.
- II. If the same rate is offered by more than one tenderer then the Division Forest Officer, Sambalpur Forest Division immediately after opening such tenders will permit those tenders who are present and who have offered one and the same rate increase their offer and the highest offer, so increased will be considered for acceptances or otherwise in case there is refused to increase the offer or in the absence of respective tenders the tenders which are to be considered for acceptance will be decided by drawing lots.
- III. The act of the submission of the tender shall be deemed to be as unreserved acceptances of all condition herein contained.
- IV. The amount of loss, penalty compensation, interest etc. if not paid within a period of 15 days from the date of demand shall liable forfeiture of security.

#### LOSS TO SAMBALPUR FOREST DIVISION

- I. in the event of any loss to the Sambalpur Forest Division on the account of any act of commission or omission by the Contractor's employees, the contractor shall make good the loss suffered by Sambalpur Forest Division either by replacement or by payment of adequate compensation as decided by the Divisional Forest Officer, Samalpur Forest Division.
- II. In case the medicines so procured couldn't be utilized before 31.03.2025/ within the expiry date, the contractor shall replace/take refund the medicines subject to advance intimation by the DFO Sambalpur on or before 31.03.2025 or whichever is later.

### JURISDICTION OF COURTS

- All disputes, if any, shall be subject to the jurisdiction of courts in the Sambalpur.
- The Divisional Forest Officer reserves the right to accepts highest or the lowest tender at his own discretion.
- III. The DFO Sambalpur reserves the right to accept or reject any tender without any reason thereof

### EARNEST MONEY DEPOSIT (E.M.D)

- All bidders shall have to deposit earnest money of Rs. 30,000/- (Rupees Thirty Thousand)
  only in the form of a |Demand draft from a Nationalized/ schedule bank along with their
  Bid application inside the envelope.
- Demand Draft/Pay Order/Banker's Cheque obtained earlier than the date of advertisement inviting bids for supply of medicines, surgical accessories to the Sambalpur Forest Division, will not be accepted.
- III. Earnest money shall be refunded to the unsuccessful bidders within one month of award of allotment letter. The bidders have no right for demand for interest on the Earnest money. However, the successful bidder's earnest money shall be returned only once the successful bidder has deposited the security deposit.
- IV. However, in case where the bidder withdraws or modifies the bid during 100 days validity of the bid or it has come to knowledge that bidder has fraudulent practices for this bid, earnest money shall be forfeited.
- Tender received without EMD will be rejected summarily.

#### TERMINATION OF THE CONTRACT

- a) The Divisional Forest Officer, Sambalpur Forest Division can terminate the contract at any time after serving Two week's notice to the contractor for breach of any condition of the contractor if during the period of the contract the performance is not found satisfactory.
- The decision of the Divisional Forest Officer, Sambalpur Forest Division shall be be final and binding on the contractor in this regard.
- c) Failure by the contractor to comply with any statutory requirements during the period of contracts shall results in termination of the contract and subsequent disqualification for participation in any future tender in the Sambalpur Forest Division.
- d) The contractor will not be allowed to leave the contract before one year falling which contract will be terminated and the performance security will be forfeited. Failure by the contractor to comply with any statutory requirements and terms of agreement during the period of contract shall result in termination of the contract forthwith and subsequent disqualification of the contractor for participation in any future tender at the Sambalpur Forest Division, the security deposit will be forfeited.
