Sealed tender in the prescribed form to be eventually drawn-up in Standard Forest Department Form P-1 (Percentage Rate Bids) in conformity with the Detailed Tender Call Notice is invited by the Divisional Forest Officer, Sambalpur Kenduleaves Division, Sambalpur on behalf of Governor of Odisha in **DOUBLE COVER SYSTEM** only on “**ONLINE**” for the construction of works as detailed in the table below from “**A & B**” **Class Contractors** registered with the state Governments and contractors of equivalent Grade / Class registered with Central Government / MES / Railways for execution of Composite Building works, on production of definite proof from the appropriate authority. The bidders may submit bids for the following works.

3. The Bid documents will be available in the website www.tendersodisha.gov.in from **10.00 AM. of 01.01.2026 to 4.30 PM of 12.01.2026**. The Bid documents will be opened on **5.00 PM of 12.01.2026**.
4. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
5. Bids shall be received only “**Online**” on or before **4.30 PM of 12.01.2026**.

6. Bids received online shall be opened at **5.00 PM on 12.01.2026** in the office of the Divisional Forest Officer, Sambalpur Kenduleaves Division, Sambalpur, Odisha in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

7. Engineering contractors who are desirous to avail the facility of exemption of EMD / ISD are required to submit the scan copy of affidavit along with bid document to the effect that he / she had not yet availed the facility during current financial year as per codal provision.

8. The SC / ST contractors willing to avail the facilities as fixed by Government will submit scan copy of the affidavit for the same along with tender document; otherwise they will not be entitled to avail such facilities.

9. Additional Performance Security shall be submitted by the successful bidder when the bid amount is less than the estimated cost put to tender as per DTCN.

10. The Original documents uploaded by the bidder in the e-Procurement system of Govt. of Odisha pertaining to this bid shall be presented before the tender selection committee at 5.00 PM in the conference hall of DFO, Sambalpur (KL) Division on dated 12.01.2026 for verification and finalization of tender.

11. Other details can be seen in the bidding documents.

12. The Addendum / Corrigendum if any will be hosted in the website only.

13. The authority reserves all the rights to cancel any or all bids without assigning any reason.

14. As per OPWD code Clause 12.4 Appendix-IX(A) the contractors participated in the above tender mandated to register themselves in Contractor Data Base Management System (CDMS) available at www.cdmsodisha.gov.in.

15. Engineering Contractors desirous of availing EMD exemption shall submit a scanned copy of an affidavit alongwith the bid document, declaring that they have not availed the facility during the current financial year as per codal provisions.

16. SC / ST Contractors willing to avail Government-approved facilities shall submit a scanned copy of the relevant affidavit alongwith the tender documents; otherwise they will not be entitled to such facilities.

17. Additional Performance Security shall be submitted if required, as per DTCN.

18. In case of equal lowest bids, lottery will be conducted and bidders will be informed.

19. As it is a percentage rate tender, the bidder quoting zero value is valid and will be taken as schedule rates.

20. Additional performance security shall be submitted by the successful bidder if the bid amount is lower than the estimated cost put to tender as per DTCN clause.
