Sealed tenders are invited in plain paper from the intending buyers for sale of the old confiscated vehicles of the following description on "as is where is basis" presently available at Range Office Campus, Tangi, Balugaon & Ranpur. The earnest money to be deposited for each vehicle is mentioned against each in the list furnished below (Annexe-

1)The tender amount should be deposited in shape of a demand draft in favour of the Divisional Forest Officer, Khordha Forest Division, Khordha payable at State Bank of India, Khordha.

2)The tender will be received from dtd.18.12.2025 during office hours and up to 11 A.M of dtd. 31.12.2025 in the office of the undersigned. The tenderers may submit the tender by Regd. Post or drop the sealed tender envelop kept in the premises of Divisional Forest Officer, Khordha.

3)The entire sealed tender envelop should be super scribed with "Tender sale of confiscated vehicle" and name & address of the person who submitted tender envelop. The tenders will be opened on the same day i.e. dtd.31.12.2025 at 3 P.M. in presence of the tenderers or their authorized representatives with Aadhar Card as Identity Card.

4)The participant should have valid GST registration. The successful tenderers shall have to deposit 50% of the quoted amount including GST immediately after the announcement of tender result and the rest amount within 7 days.

5)In case of unsuccessful tenderers the draft of E.M.D. will be refunded soon after the declaration of the result. In case of default in payment of highest tender amount by the successful tenderers within the stipulated period, the E.M.D. and deposited amount shall be forfeited to Govt. and the vehicle will be put to fresh tender sale.

5)The undersigned reserves the right to either accept or reject any tender without assigning any reason thereof. The intending tenderers should inspect the vehicles & relevant papers before tender sale and no complaint shall be entertained after the tender sale is completed.

6) Once the sale is ratified in the name of the highest tenderer all the liabilities, if any, will be of the tenderer & no claims for any paper which are not available in this office will be entertained. Once the tenderer files the tender paper, it will be presumed that he has already fully satisfied himself about the present condition of the vehicle, liabilities or availability of the relevant paper of the said vehicle.


7) The undersigned is not bound to accept the highest tender & reserves the absolute right to accept any tender or reject any or all the tenders without assigning any reason thereof. The intending tenderers are required to submit copy of Voter Identity Card or Aadhar card for their identification along-with the tender papers.

8)The successful tenderers shall remove the vehicles from the site within 7 days from the date of depositing the full tender amount, failing which ground rent at the rate of 1% of tender money shall be charged for each day or part of the day upto 30 days. Beyond 30 days the tender deemed to be cancelled and deposit amount will be forfeited.

9)Custody or safeguard of the vehicle shall be the responsibility of the tenderer and no claim or complaint on that account shall be admissible. Where the ground rent so charged exceeded the sale price deposited, the tenderer shall cease to have any right on the vehicle.

10)The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of Govt. free from all encumbrances and dispose off by fresh sealed tender as the case may be.
