In case the bidder intended to quote less price than the amount put to tender shall be abide by the Govt order No. 4559 dt. 05.04.2021 i.e. amendment to Para-3.5 (v) of OPWD Code, Vol-I with modification that "Additional Performance Security shall be deposited within 7 days of the issue of letter of acceptance by failing which the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.
