

## **Terms & conditions of Tender sale of confiscated vehicles of Brahmapur Forest Division, Brahmapur, Ganjam.**

1. The Divisional Forest Officer, Brahmapur Division, Brahmapur invites sealed tenders by Registered Post/in person from the intending buyers herein after called the Tenderer (s) quoting their offers for purchase of the confiscated vehicles on "as is where is basis" presently available in the campus noted against each. The tenders will receive tender paper on or before **dtd. 27.01.2025 up to 5.30 PM** in the Office of the under signed i.e. Office of the Divisional Forest Officer, Brahmapur Division, Brahmapur. The tender papers will open on **dtd. 29.01.2025 at 11.00 AM** in the office of the under signed in presence of all intending purchasers or their authorized representatives.

2. The intending purchaser are advised to obtain the tender form from the office on payment of non-refundable amount of **Rs.50/- (Fifty)** S.B.I Bank draft only & inspect the vehicle on any working day well in advance before submitting their tenders.

3. The very act of giving offer in the tender form, the tenderers shall be deemed as a proof that the tenderers have inspected the vehicle & satisfied himself about its condition. No complains at later stage shall be entertained nor shall any claim for grant of refund on purchase amount will be entertained on any ground, what so ever after the tender is concluded. The department will not be held responsible for any dispute on the condition of the vehicle after the sale.

4. The tenderers must be having GST registration number which was submitted with the tender form.

5. The tender terms should be filled clearly & legibly. The offer quoted should be written both in figures & words. Correction & overwriting if any, should be attested by the tenderer/purchaser. The full name & complete address of the purchaser/tenderer should be clearly written in the tender paper. The tender paper without signature & without E.M.D. will be summarily rejected.

6. The tender paper should accompany with an Earnest Money Deposit (E.M.D) in shape of Account Payee Bank Draft drawn in favour of the Divisional Forest Officer, Brahmapur Division, Brahmapur payable at State Bank of India, Brahmapur. No cash will be entertained. In case of successful tenderers, the E.M.D. will be adjusted towards Security Deposit and in case of un-successful tenderer the E.M.D. will be refunded on the day of the opening of tender.

### **E.M.D Amount**

E.M.D. for heavy vehicle	Rs. 12000/-each.
E.M.D for light vehicle	Rs. 6000/- each.

7. The successful tenderer shall have to deposit at least 25% of the amount quoted in tender on the spot immediately after announcement of the tender result as Security Deposit to be adjusted towards the sale value & balance 75% shall have to pay within 7(Seven) days from the date of issue of orders on approval of the offer.

8. Prevalent rate of Taxes etc. if any, will be borne by the buyer on the sale value.

**9.** The successful tenderer if fails to deposit the full Sale value & Taxes if any, within the stipulated time i.e 7 days from date of issue of orders on approval of offer. The department will be at liberty to forfeit the entire amount (including earnest money) deposited by the tenderer to the Government and the vehicle will be put to fresh sale as would be deemed proper.

**10.** The successful tenderer shall remove the vehicle from the office premises/depot within 7(Seven) days from the date of full payment of amount offered by him including taxes if any, failing which custody or safeguard of the vehicle shall be the responsibility of the tenderer/party & no claim/complaint of any sort shall be entertained thereafter.

**11.** The successful tenderer will be charged ground rent @ 1% of the tender amount each per day or part of the day till the removal of the vehicle from the site thereof if, he fails to remove the vehicle as per clause no.9 of the terms & conditions of the tender.

**12.** The vehicle shall not be handed over to the tenderer until unless payment of full amount including taxes if any, is made & requisite formalities are being complied with tools, implements & spare parts shall not be handed over with the vehicle.

**13.** Where the ground rent so charged exceeds the sale price deposited, the tenderer/party shall cease to have any right on the vehicle. The sale price so deposited will be adjusted towards ground rent and the vehicle will become the absolute property of the Government, free from all encumbrances & will be disposed of by fresh sealed tender as the case may be at the risk of the successful tenderer.

**14.** The undersigned reserves the right to accept or to reject any tender without assigning any reason thereof for violation of the term and condition laid.
