

- The Tender Paper cost and Earnest Money Deposit / Bid security/ of the amount specified for the work in Col.4 and 5 above, the bidder shall make Demand Draft using his / her with any scheduled or Nationalized Bank. The EMD & Tender Paper cost will be made in favour of Divisional Forest Officer Sundargarh payable at Sundargarh.
- The Bid documents, DTCN & BOQ will be available in the Sundargarh portal i.e **<https://sundargarh.odisha.gov.in>** from **10.00 A.M Dated.17.09.2025 to Dated.30.09.2025 up to 5.00 P.M** for offline bidding.

6. The bidders are sent their bids through Speed post/ register post / courier only on or before Dt.30/09/2025 upto 5:00 PM.
7. Bids received shall be opened at **11:00 AM on Dated. 03.10.2025** in the office of the **Divisional Forest Officer, Sundargarh Forest Division, Sundargarh** in the presence of the bidders. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
8. The cost of bid documents as mentioned in Column 5, the bidder shall make Demand Draft with any scheduled or Nationalized Bank.
9. The Engineer contractor willing to avail the Exemption of EMD will submit scan copy of the affidavit to avail the exemption along with bid document and original affidavit will be submitted before opening of technical Bid. Affidavit should contain how many times such facilities have been availed by him prior to this during the current financial year. Otherwise, they will not be entitled to avail such facilities.
10. The SC/ST contractors willing to avail the facilities as fixed by Govt. will submit an affidavit for the same along with tender document; otherwise, they will not be entitled to avail such facilities. Claim at the time of opening of tender or later will not be entertained.
11. Other details can be seen in the bid documents (DTCN).
12. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in off-line bidding.
13. If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant Codal practice will be taken against him /her.
14. If after opening of the tender it is seen that, if the rate quoted by more than one bidder is found to be equal & lowest the tenderer has to be decided through a transparent lottery system then the lottery date will be intimated through e-mail & speed post. The lottery will be held even if no bidder remains present.
15. Conditional tender will be summarily rejected. The Authority reserves the right to reject any or all bids without assigning any reason thereof.
