The Owners are to quote the monthly hire charge inclusive of taxes if any but the cost of fuel, which will be borne by this Division. The details of terms and condition for engagement of trawler can be obtained from the Office of the undersigned during office hours from **07th October-2024** onwards. Quotation for hiring of trawler (400 HP) to submitted separately.

**TERMS AND CONDITIONS FOR ENGAGEMENT OF TRAWLER FOR
PROTECTION OF SEA TURTLE DURING 2024-25.**

1. The Trawler owner shall be paid _____ (Rupees _____) per month towards hire charges of the fully equipped and manned Trawler. No separate charges are payable to crew members and for repair / maintenance of his Trawler.
2. The Trawler bearing _____ shall be under the control and supervision of Divisional Forest Officer, Puri Wildlife Division, Puri who shall deploy it and use it as per requirement i.e. patrolling in the prohibited zone to prevent unauthorized fishing in the zone prohibited under the provisions of OMFRA. It shall be kept in excellent working condition throughout the period of its agreement at all hour of the day. The period of engagement of the Trawler if from **November-2024 to March-2025**. The period may be extended depending upon the exigency.
3. The Trawler will be ordinary kept at bank of Kadua River in front of Ganga Devi temple or at Nuagarh Jetty so that effective control can be exercised in the entire Devi Coastal waters. The SONA trawler of 400 HP may come to Astaranga harbour for water and other provisions as and when required or any area in high sea as per requirement of Forest Department intimated through DFO, Puri Wildlife Division.
4. Fuel in the shape of diesel at a rate of 10 (ten) liters per hour of use will be supplied by the Department.
5. Engine oils and any other consumable required for the running of trawler shall be provided by the Owner at his cost.
6. If for reason whatsoever the owner is unable to provide the Trawler for use then he shall make alternative temporary arrangement by providing another trawler of the same type for the purpose.
7. Payment shall be made monthly in favour of the trawler owner on receipt of the bills through Range Officer, Astaranga who will certify regarding period / time of engagement.
8. A log book shall be maintained by the trawler captain which will bear the details of hour of use and the area of use. This log book shall be signed by the trawler captain and head of the enforcement staff whenever the trawler is taken for sortie. This will be the property of Govt.
9. Department will not be responsible for any damaged to the trawlers or crew members during the operation.
10. The Trawler owner shall take care of all legal formalities like registration, insurance cover for the trawler and its staff and the hirer will be in no way responsible for such requirement.
11. The hirer is at liberty to affix wireless set, antenna, GPS-PDA, Flags, Gun, mount, life jacket, search light, loudspeaker or any other instrument of equipments necessary for the turtle protection work in the prohibited zone as per prohibited zone as per provisions of OMFRA.
12. The hirer shall be at the liberty to discontinue hiring of the trawler during the current hirer period without assigning any reason thereof.
