2. The bidder shall have to deposit the cost of tender paper @ Rs.1000/- for participation in the bid in shape of Bank Draft/Banker's Cheque etc. in favour of Divisional Forest Officer, Redhakhol Forest Division. The Tender cost is non-refundable in nature. Cheques will not be accepted.
3. The Bid documents will be available on the website www.redhakholforest.com or <https://sambalpur.odisha.gov.in> or www.odishaforest.in from 18.08.2025 to 29.08.2025 up to 5.00 PM.
4. Bids Shall be received "OFFLINE on or before 5.00 PM of dt 29.08.2025 in the Drop box placed in the office or thorough postal/Courier.
5. Bids received shall be opened at 11.00 hours 30.08.2025 in the office of undersigned in the presence of the bidders who to attend.
